

Hast Will and Testament OF ERIC NORTON

I, **Eric Norton**, a resident of Shelby County, State of Alabama, being of sound mind and disposing memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other wills and codicils thereto made by me.

ITEM ONE: I give, bequeath and devise all my property, realty and personalty of whatever kind, as follows:

- (A) Family heirlooms that have been passed down from my parents and grandparents shall be equally divided amongst my three (3) children as named herein; and
- (B) any and all of my remaining property whether real or personal and wherever situated shall be devised and bequeathed as follows:
 - (i) two (2%) percent of the estate to my beloved son Richard Norton;
 - (ii) four (4%) percent of the estate to my beloved daughter Laurel L. Barton;
 - (iii) six (6%) percent to my beloved daughter Nancy L. Norton;
 - (iv) eighty eight (88%) percent to Katsufusa "Tom" Azuma.

ITEM TWO: I do hereby designate Katsufusa "Torn" Azuma, as Executor hereunder, if he survives me. If he shall resign or for any reason fail or cease to serve as Executror, then I hereby designate and appoint Lyman Marfell as successor Executor hereunder.

- (A) I direct that neither my Executor nor successor Executor shall be required to give bond or to file an inventory or appraisal of my estate though they shall make out and keep an inventory and shall exhibit the same to any party in interest at any reasonable time, and a direct that they shall be free from the control and supervision of any court.
- (B) I hereby vest in my Executor and successor Executor full powers of management, control and disposition of my estate, including the power to sell any or all of the property in my estate at public or private sale without the supervision of any court.

ITEM THREE: I direct that all of my debts, including the expenses of my last illness and funeral, shall be paid out of my estate by my Executor and successor

Executor, as soon as practicable after my death.

ITEM FOUR: My Executor and successor Executor shall employ counsel of choice to handle all legal matters concerning the administration of my estate and shall pay unto such counsel reasonable compensation for such services out of income or principal as under the circumstances he may deem proper.

ITEM FIVE: In the event it becomes necessary to have administration of my estate or of any trust or share thereof in any state other than Alabama and the persons named above do not qualify therefor, they or any of them, may nominate and appoint any person or organization an ancillary administration and make such disposition of the property administered by it as the persons named above may require, and in doing so it shall have the same rights, powers, duties and discretion herein conferred upon the executor (or executrix).
