KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Two Hundred Eighty-Eight Thousand Four Hundred Fifty and 00/100 (\$288,450.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Peter Shane Martin and wife, Holly Marie Martin**, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEES herein, the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Nicholas B. McRae and Rebecca Talty McRae**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 14A, according to the Survey of Dunnivant Square Resurvey, as recorded in Map Book 42, Pages 123 A, B & C, in the Office of the Judge of Probate of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Area as more particularly described in the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Dunnivant Square as recorded in Instrument #20100713000222660, in the Probate Office of Shelby County, Alabama, as may be amended from time to time (which together with all amendments thereto, is hereinafter referred to as the "Declaration").

Subject To:

Ad valorem taxes for 2016 and subsequent years not yet due and payable until October 1, 2016. Existing covenants and restrictions, easements, building lines and limitations of record.



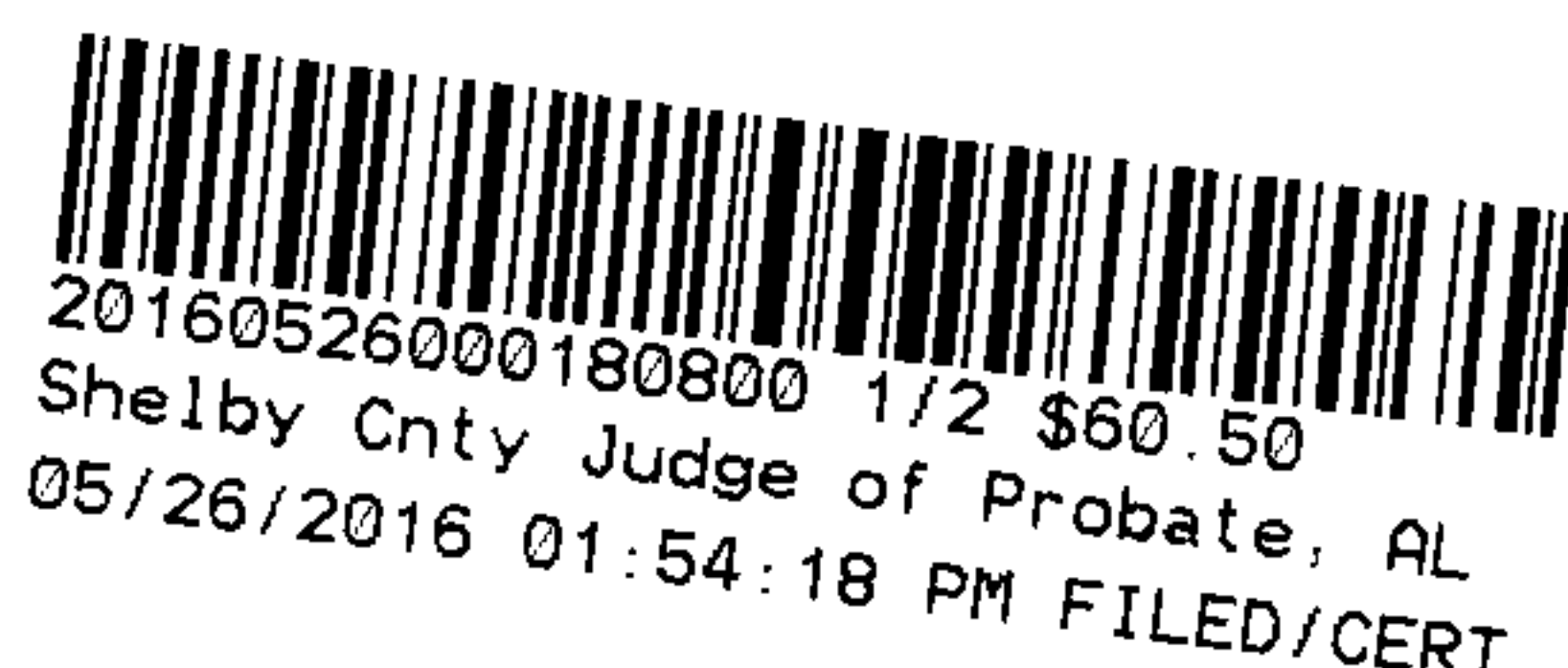
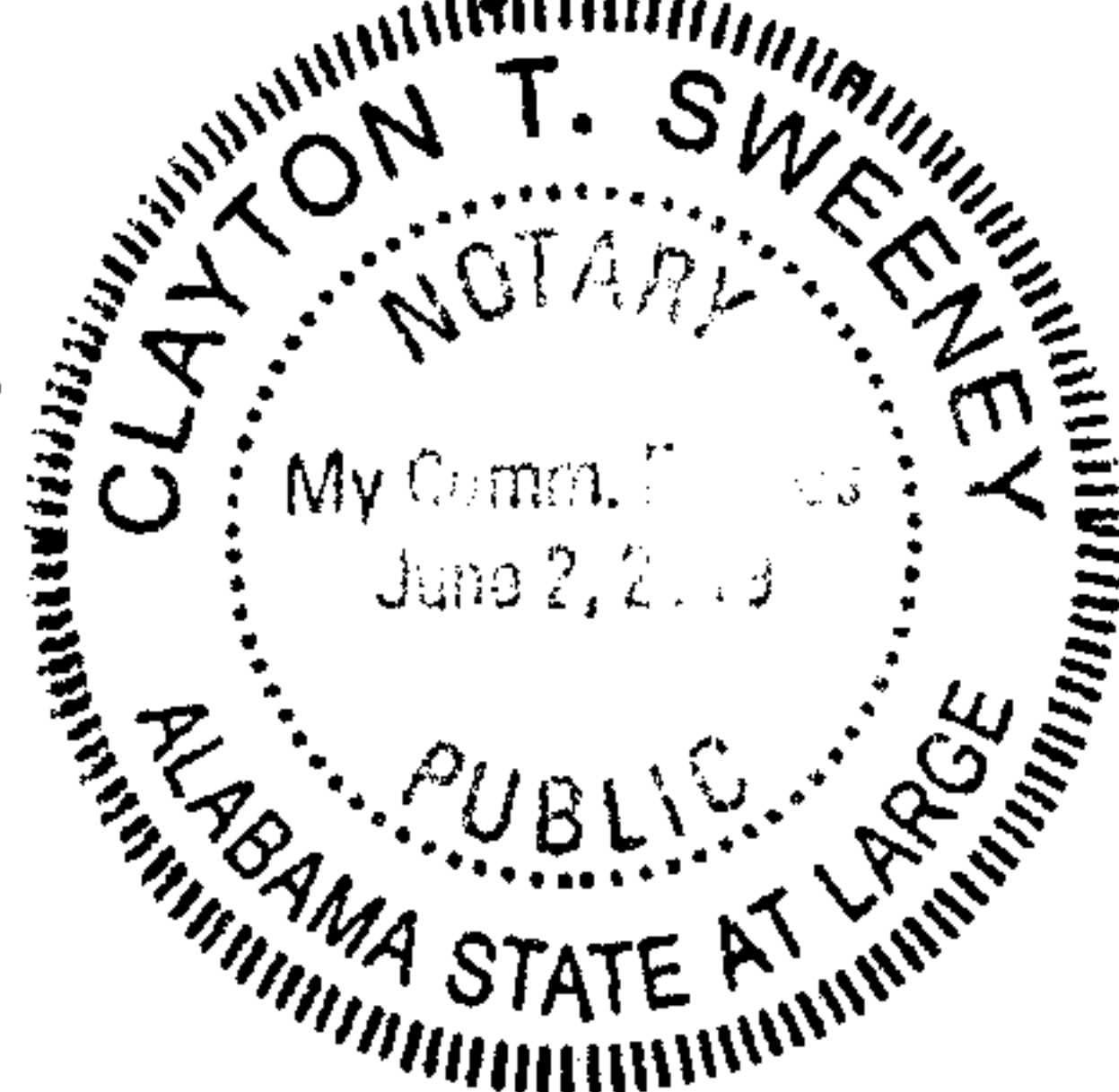
