KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of March, 2007, James Neal Allen and June Allen, his wife, executed that certain mortgage on real property hereinafter described to First Financial Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20070327000136690, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., by instrument recorded in Instrument Number 20160303000068650, in the aforesaid Probate Office ("Transferee"); and



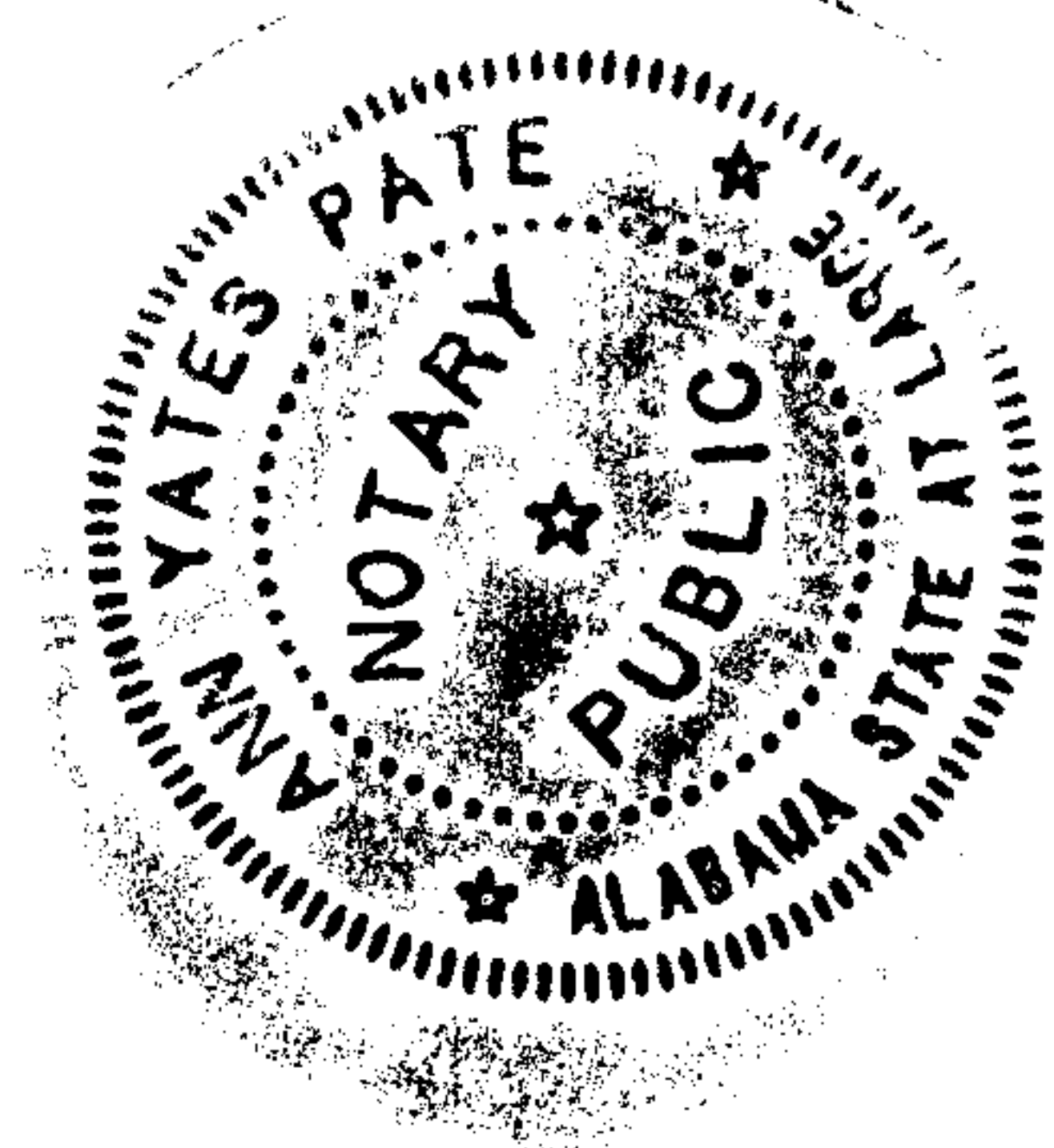
