KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 20th day of March, 2003, Eugene M. Holder, II aka Eugene Michel Holder, II and Charlotte C. 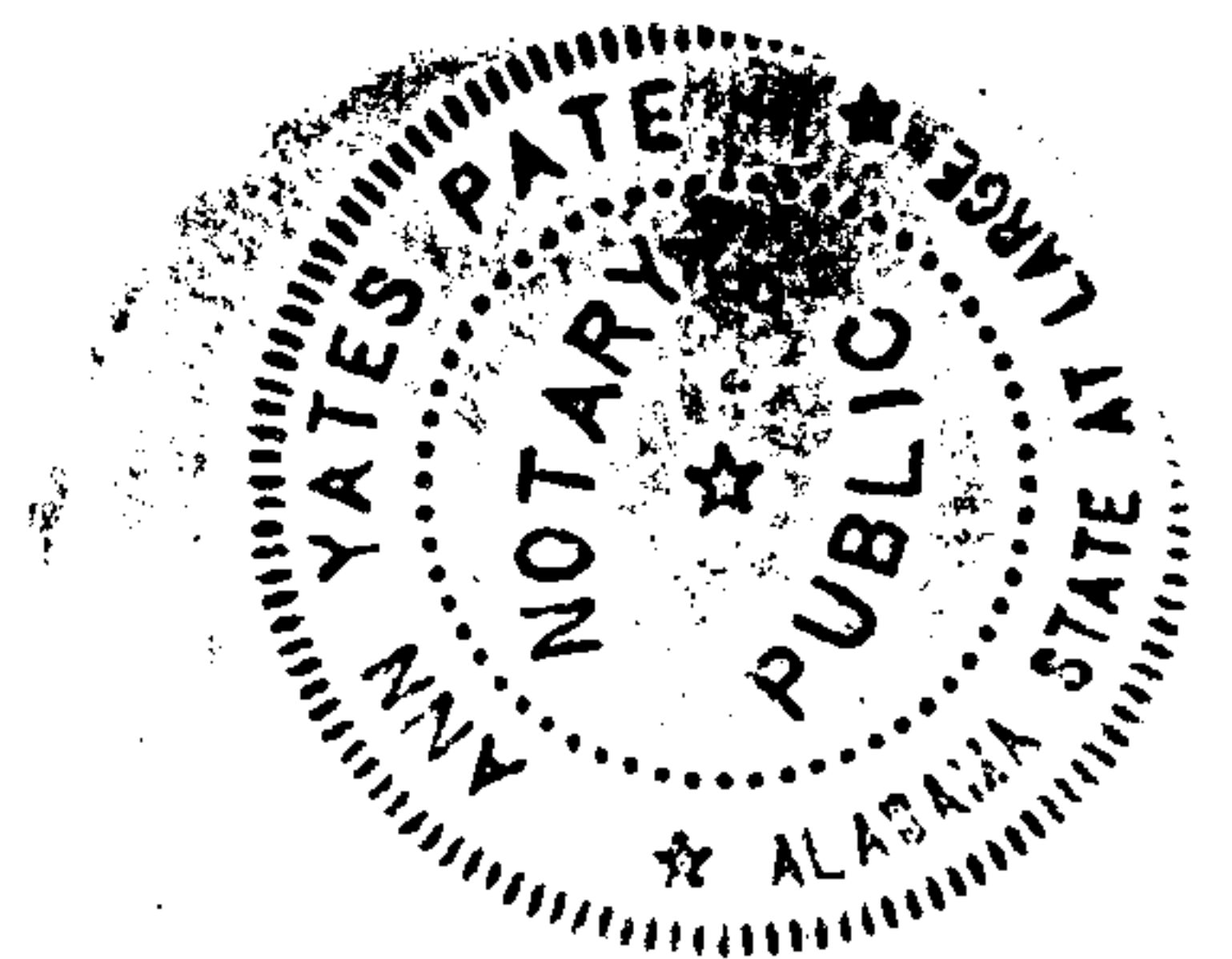
