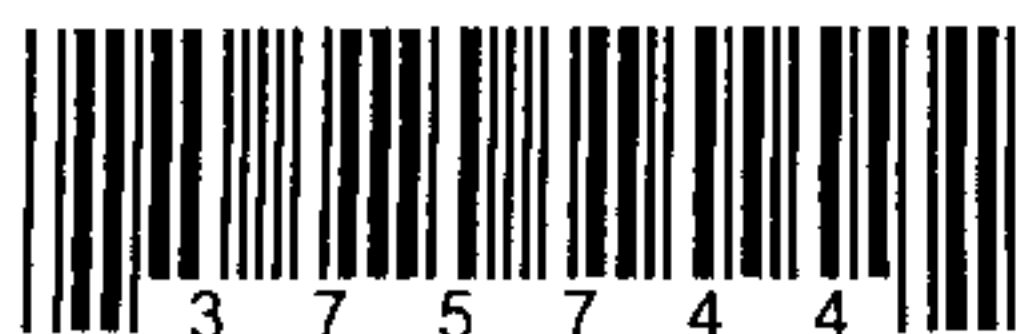
FORECLOSURE DEED

WHEREAS, heretofore, on, to-wit: the 7th day of April, 2009, Timothy L. 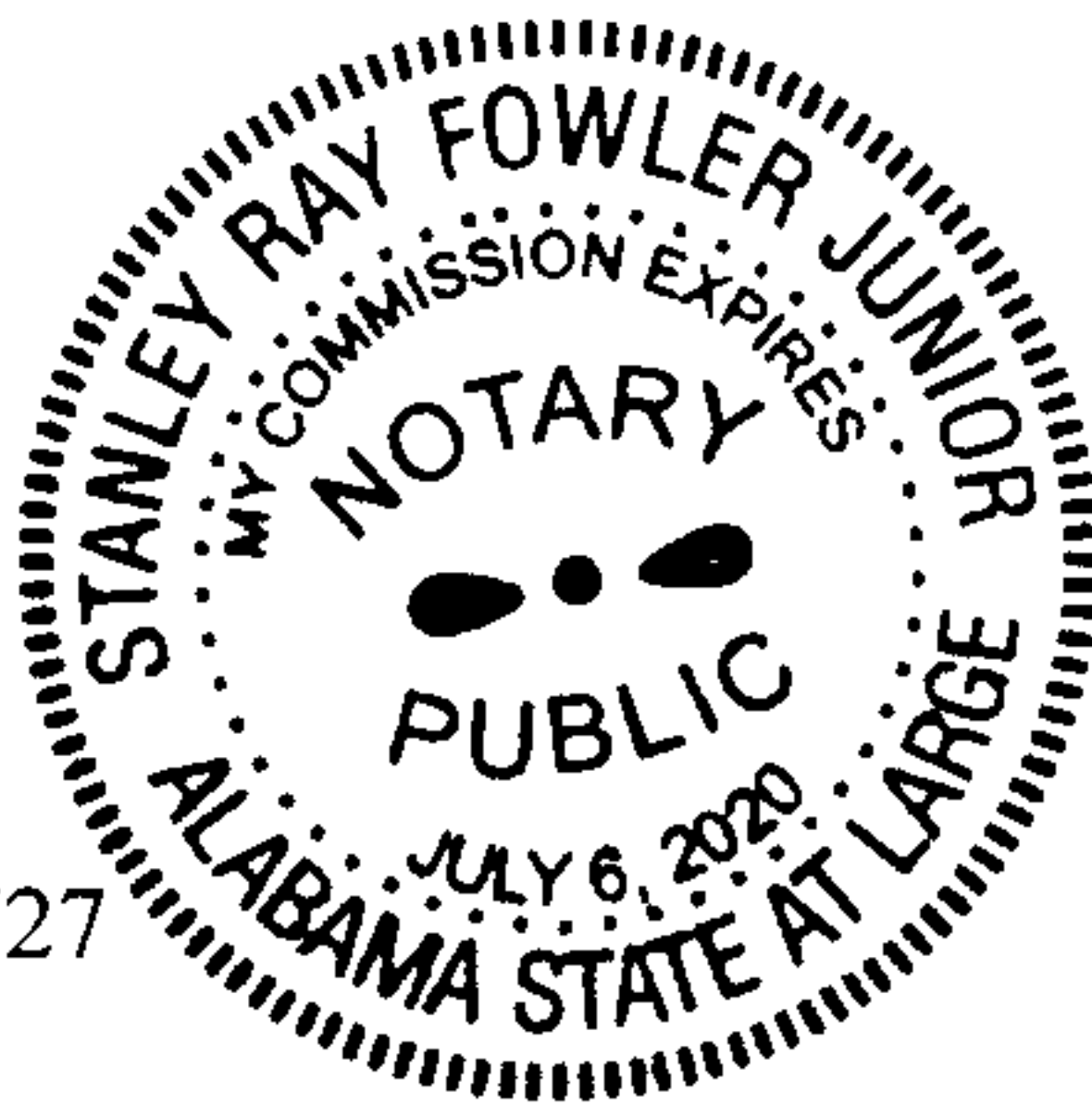
