
AUCTIONEER'S DEED



STATE OF ALABAMA COUNTY OF SHELBY

WHEREAS, Jessie Caldwell and Lummie Caldwell, husband and wife executed a mortgage to Mortgage Electronic Registration Systems, Inc. (MERS) acting solely as nominee for Lender, Countryiwde Bank, FSB, and Lender's successors and assigns dated September 29, 2008, and Recorded in Instrument Number 20081013000402770 of the records in the Office of the Judge of Probate, Shelby County, Alabama, which said mortgage was subsequently assigned to Bank of America, N.
