**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Six Hundred Thousand and 00/100 Dollars (\$600,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**Charles H. Crauswell, and his wife, Patricia K. Crauswell**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**Robert E. Butterworth and Debra F. Butterworth**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

**Lot 493, Caldwell Crossings, Fourth Sector, Phase 1, as recorded in Map Book 36, Page 28, in the Probate Office of Shelby County, Alabama.**

**\$250,000.00** of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2016 ad valorem taxes not yet due and payable;  
(2) all mineral and mining rights not owned by the Grantors; and  
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

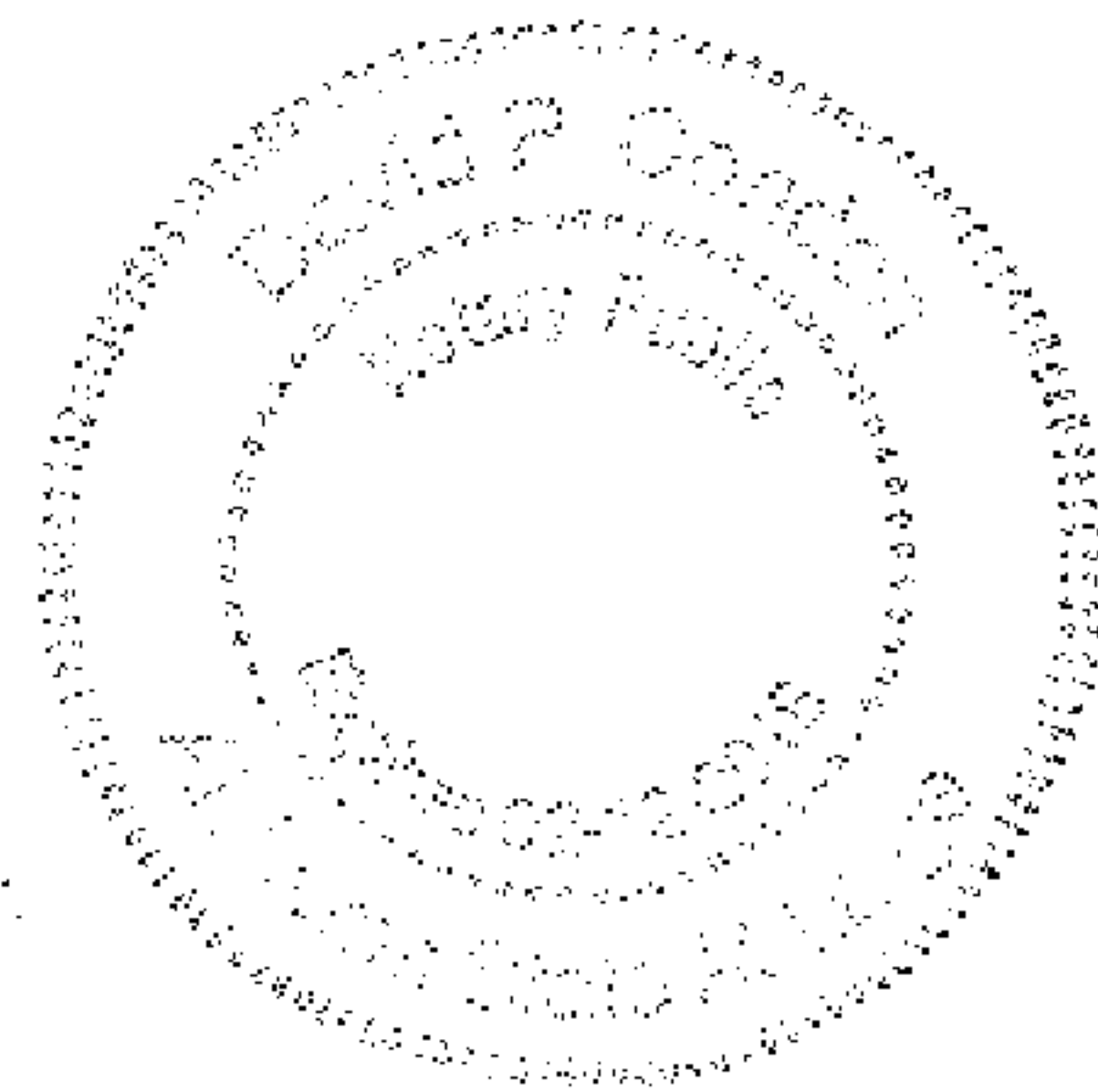

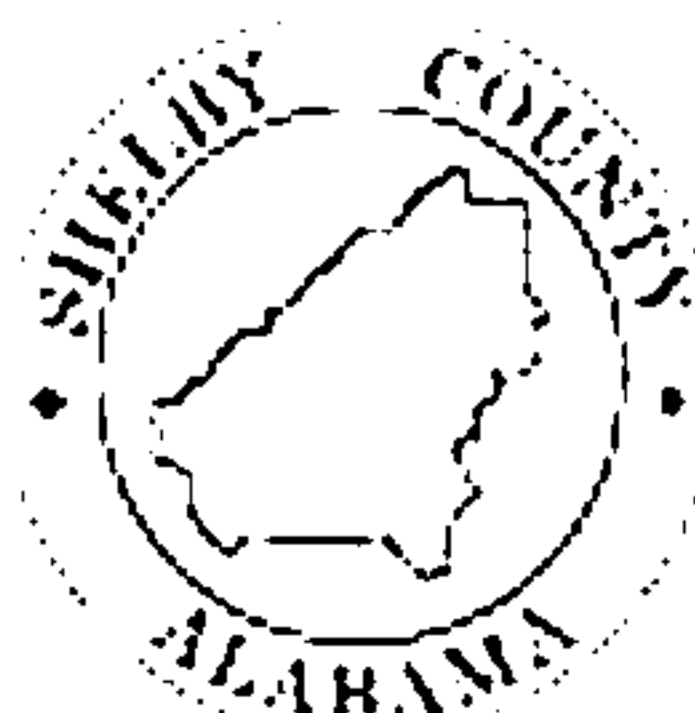
