FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 13th day of November, 2012, James C. Scholl, a single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for IberiaBank Mortgage Company, An Arkansas Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20121129000457840, said mortgage having subsequently been transferred and assigned to IberiaBank Mortgage Company, by instrument recorded in Instrument Number 20140730000235240, in the aforesaid Probate Office ("Transferee"); and

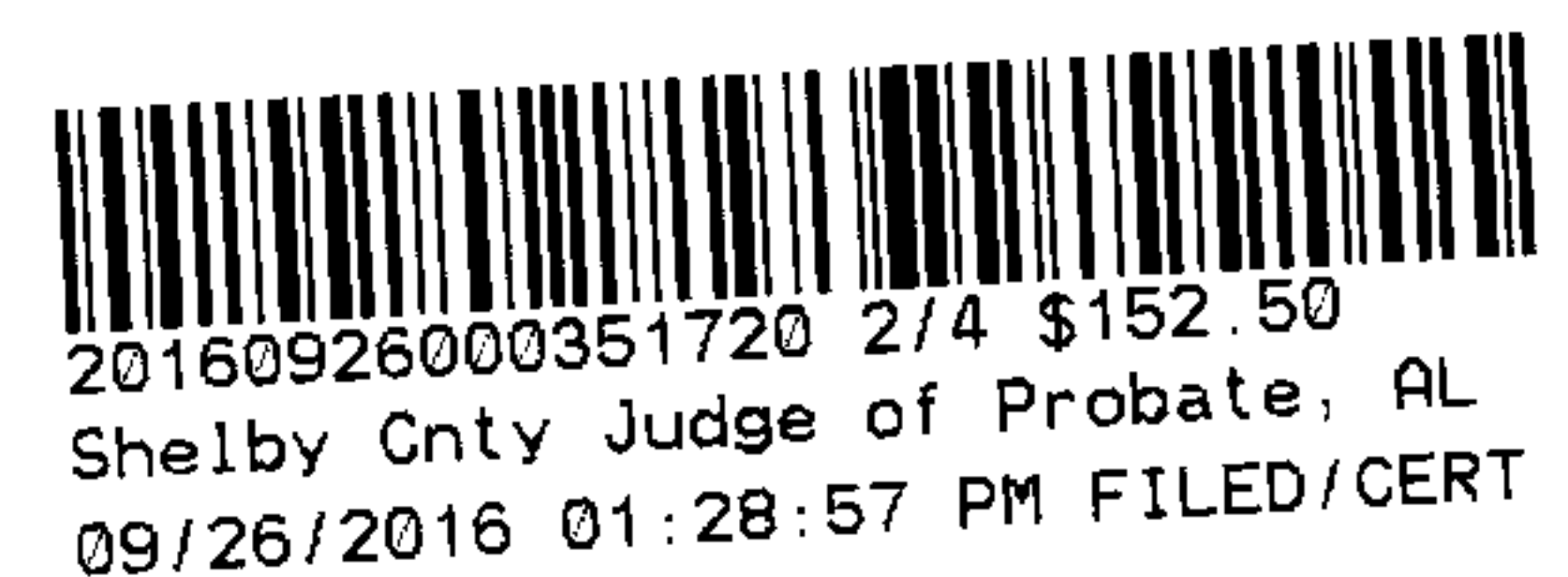

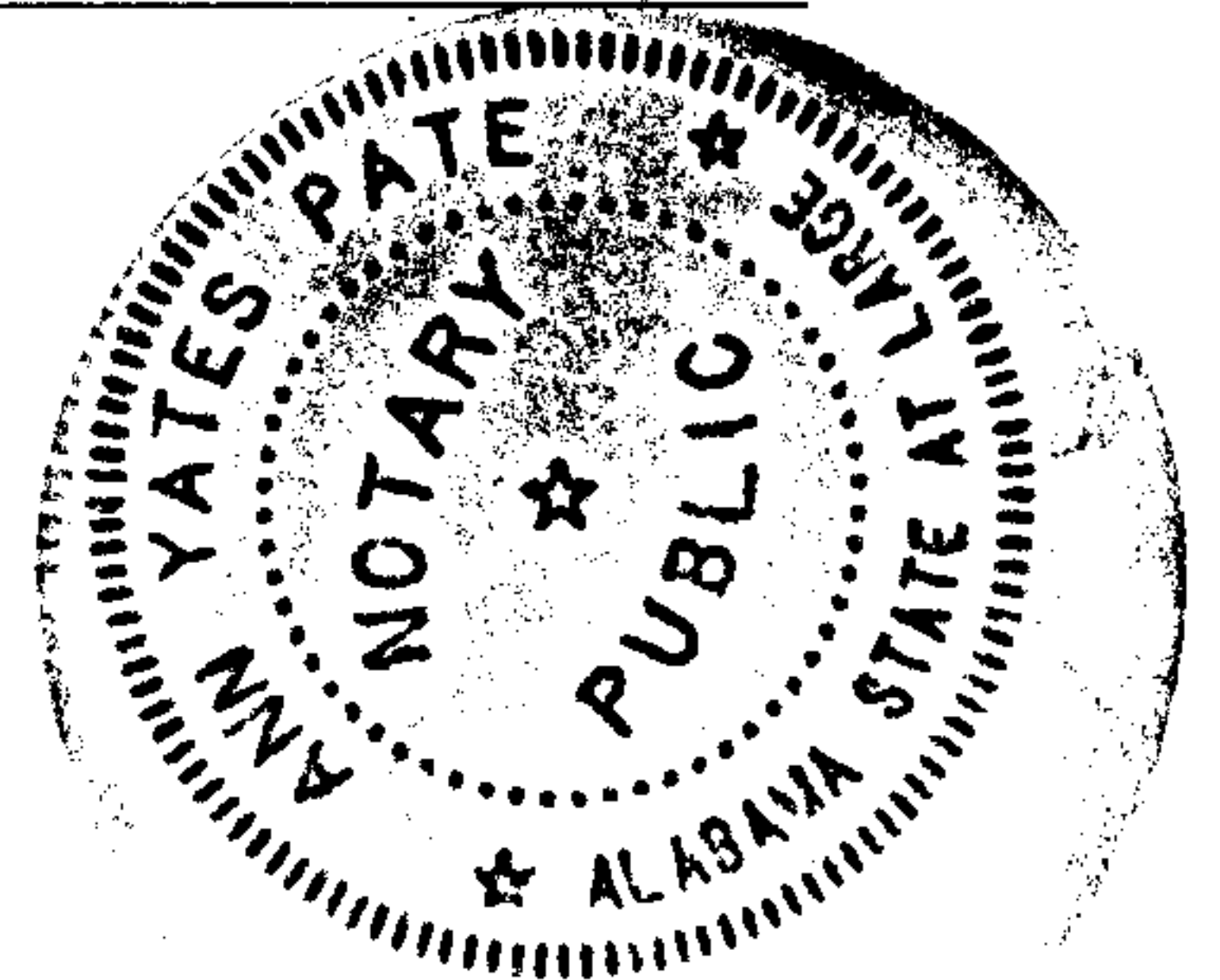
