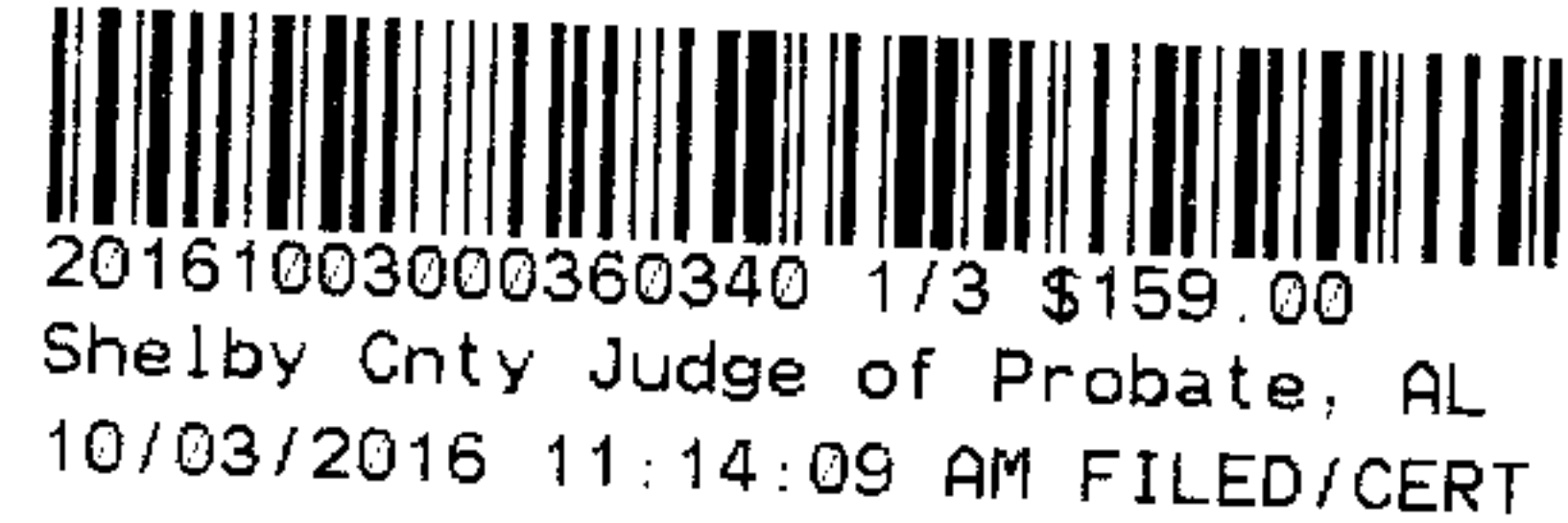

CERTIFICATE OF FORMATION

OF

The undersigned, desiring to form a limited liability company pursuant to the laws of the State of Alabama, certifies as follows:

1. The name of the limited liability company is RESTING S RIDES, LLC.
2. The existence of the limited liability company will commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration will be perpetual; provided, however, that the limited liability company will be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Law.

6. The location of the initial registered office is 3230 Cahaba Valley Road, Indian Springs, Alabama 35124.


