Jones, a single individual, (herein referred to as GRANTOR) does hereby grant, bargain, sell and convey unto John David Genry and Jessica Genry, husband and wife, (herein referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

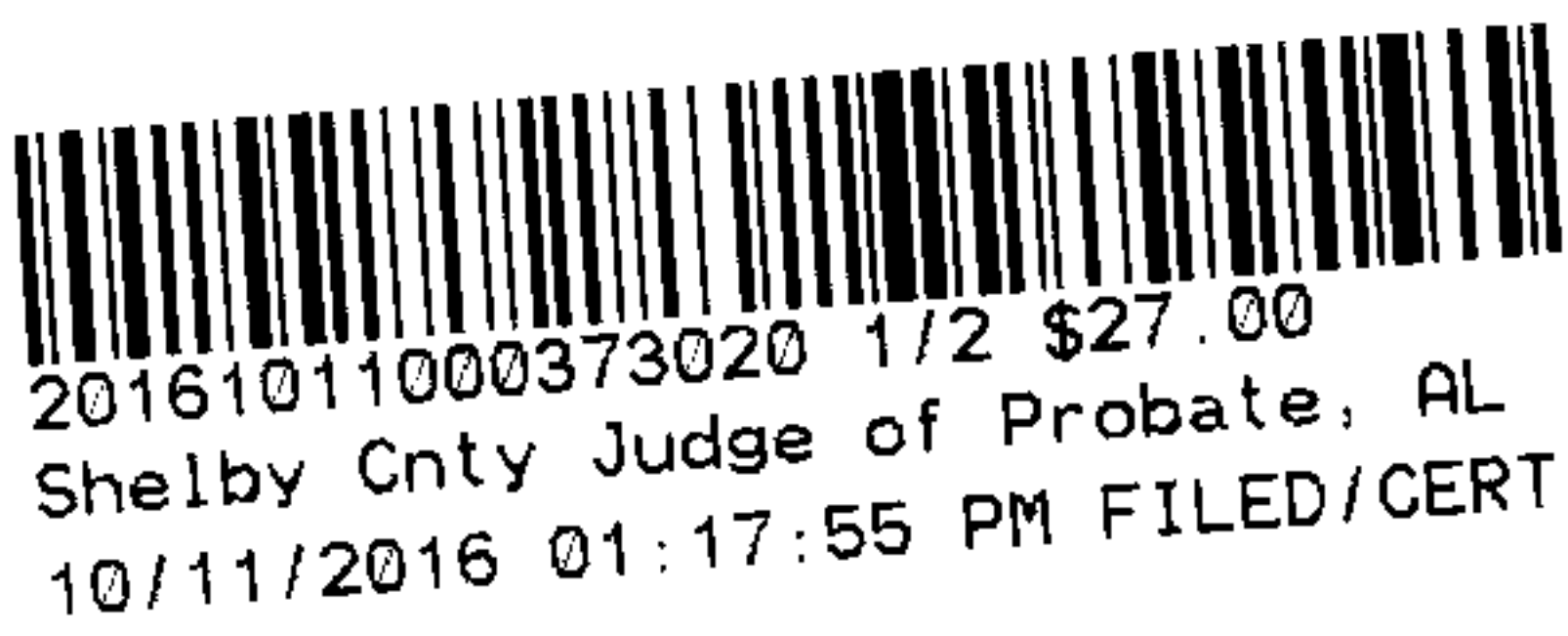
