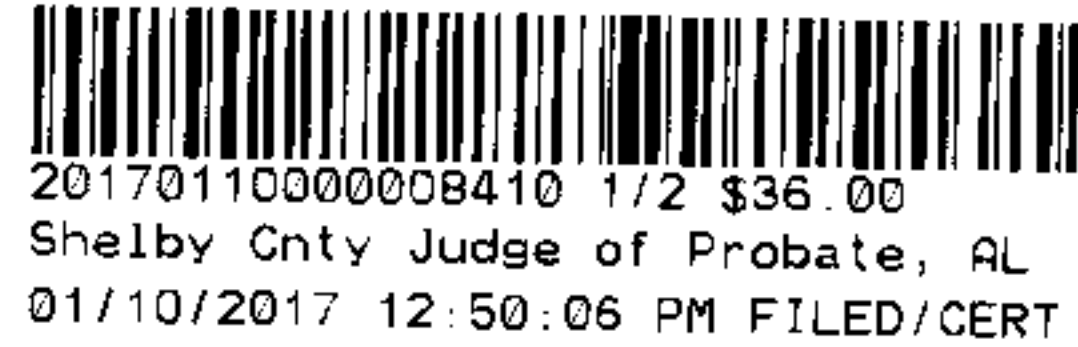


## NOTARY BOND

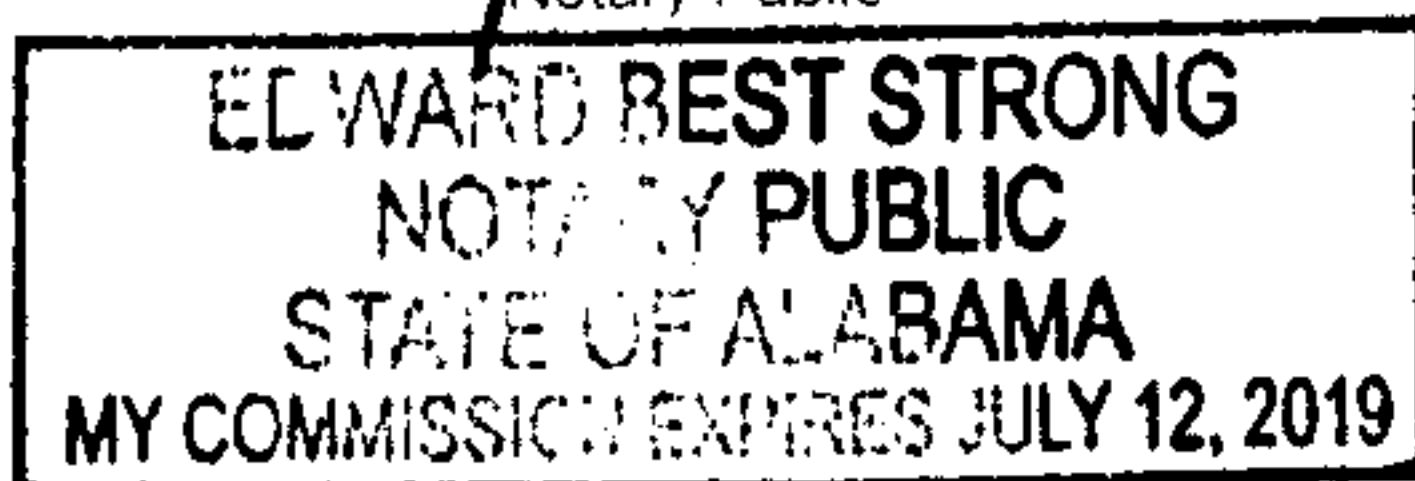
OATH OF OFFICE
