**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Two Hundred Ninety-Eight Thousand and 00/100 Dollars (\$298,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt whereof is acknowledged, I,

**Shirley A. Thomas, an unmarried woman**

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

**Wilbur Leland Holaday, Jr. and Elsa Ruth Holaday**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:

**Lot 24, according to the Survey of Meadowridge, as recorded in Map Book 11, Page 40 A & B, in the Office of the Judge of Probate of Shelby County, Alabama**

\$268,200.00 of the proceeds come from a mortgage recorded simultaneously herewith.

**Shirley A. Thomas is the surviving grantee of the deed recorded in Deed Book 225, Page 281, as the other grantee Ralph M. Thomas died on May 30, 2014. By executing this deed as attorney in fact for Shirley A. Thomas, David Russell Ponder affirms that Shirley A. Thomas is still alive and has not revoked or modified the authority granted to him in the durable power of attorney recorded herewith.**

- Subject to: (1) 2017 ad valorem taxes not yet due and payable;
- (2) all mineral and mining rights not owned by the Grantor; and
- (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

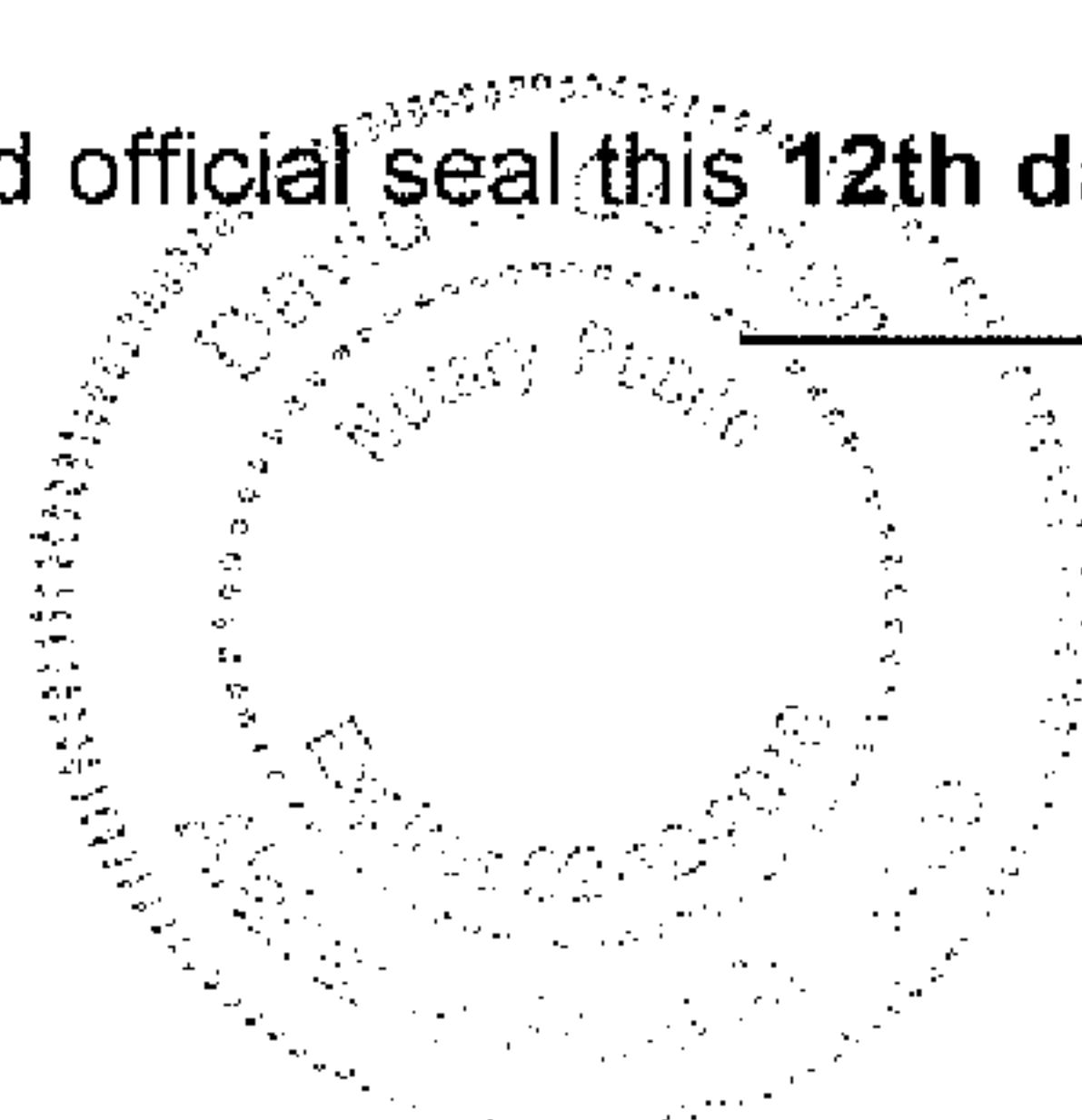

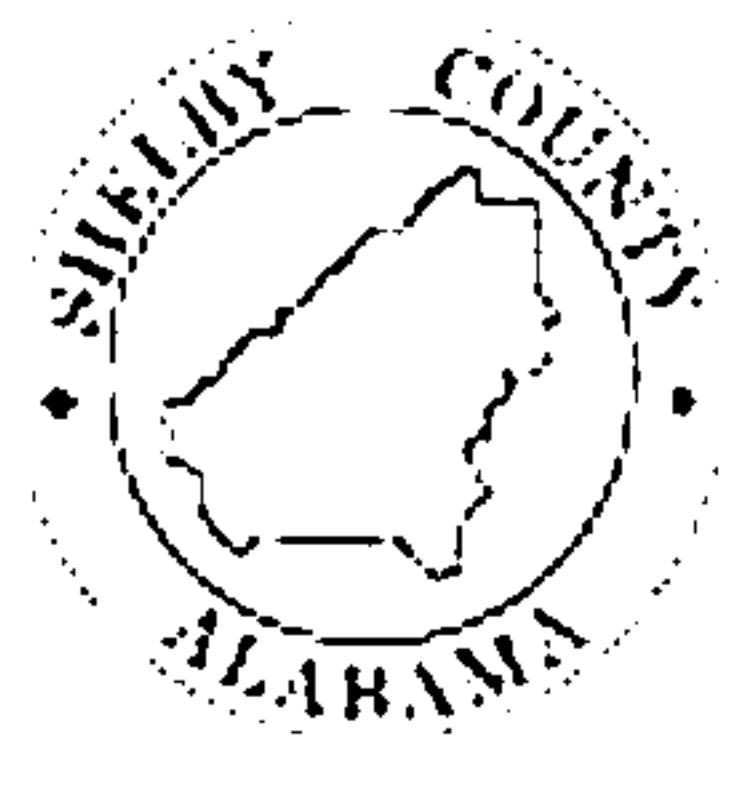
