

PERMANENT ACCESS EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One dollar (\$1.00), cash in hand paid to the undersigned by the Grantee, the receipt of which is hereby acknowledged, I (we), the undersigned grantor(s), Shelby Investments, LLC, a Georgia Limited Liability Company, have this day bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto Kay W. White and Brooke L. Carter the following described easement, lying and being in Shelby County, Alabama and more particularly described as follows:

An Access Easement across parcels of land situated in the South half of Section 13, Township 21 South, Range 5 West, Shelby County, Alabama, with Parcel Numbers 25-6-13-0-000-001.000 and 25-6-13-0-000-004.000 and a parcel of land situated in the North half of Section 24, Township 21 South, Range 5 West, Shelby County, Alabama with Parcel Number 25-6-24-0-000-001.002, being more particularly described as follows:

A 30 feet wide access easement along existing roadway otherwise known as River Road (CR-251) from where the Relocated River Road (CR-251) ties to existing River Road (CR-251) in a northerly direction to a point where an existing unnamed woods road ties to the existing River Road (a distance of 725'±); thence in a south westerly direction along the existing unnamed woods road to the property line of ID No. 25-6-24-0-000-002.000 (a distance of 3,350'±).

To Have and To Hold, unto Kay W. White and Brooke L. Carter, their heirs and assigns, in fee simple forever.


