MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, April 25, 2011, **Edward F. Jurovich, Sr., A Single Man, Mortgagor**, did execute a certain mortgage to **MetLife Home Loans, a Division of MetLife Bank, N.A.**, which said mortgage is recorded in Instrument No. 20110502000131340, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, said mortgage and the debt thereby secured was last transferred and assigned to **Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee**, as transferee, said transfer is recorded in Instrument 20170118000021700, aforesaid records, and Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee, is now the holder and owner of said mortgage and debt; and

WHEREAS, default was made in the payment of indebtedness secured by said mortgage, and the said Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of foreclosure of said mortgage, in accordance with the terms thereof, by First Class Mail and by publication in the Shelby County Reporter, a newspaper of general interest and circulation in Shelby County, Alabama, in its issues of 09/21/2016, 09/28/2016, 10/05/2016; and

WHEREAS, on January 5, 2017, the day on which the foreclosure sale was due to be held under the terms of said notice at 2:07 o'clock pm between the legal hours of sale, said foreclosure was duly and properly conducted and Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Pelham, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee in the amount of **ONE HUNDRED SIXTY THOUSAND DOLLARS AND NO CENTS (\$160,000.00)** which sum the said Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said Nationstar HECM Acquisition Trust 2016-2, Wilmington Savings Fund Society, FSB, not individually, but solely as trustee; and


