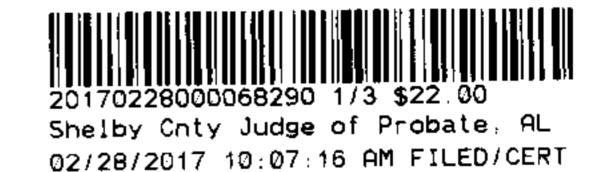

MORTGAGE FORECLOSURE DEED
