

CERTIFICATE OF FORMATION

OF

REARDON PROPERTIES, LLC

THE UNDERSIGNED, desiring to form a limited liability company pursuant to the provisions of Section 10A-5A-1.01 *et seq.*, Code of Alabama, (1975), known as the Alabama Limited Liability Company Law (the "Act"), for the purposes hereinafter stated, does hereby adopt the following Certificate of Formation:

- 1. NAME. The name of the limited liability company shall be REARDON PROPERTIES, LLC (the "Company").
- 2. <u>DURATION</u>. The period of duration of the Company shall be perpetual, unless sooner terminated as provided under Alabama law or in accordance with any operating agreement adopted by the Company ("Operating Agreement").
- 3. <u>PURPOSES & POWERS</u>. The Company is formed for the purpose of purchasing, managing, owning, holding, selling, construction, renovating and otherwise dealing with real estate and real estate investments, as well as for the further purposes of transacting any or all lawful business for which limited liability companies may be formed under the Act, as in effect from time to time. The Company shall have all of the powers as set forth in Section 10A-5A-1.04, <u>Code of Alabama</u> (1975), as in effect from time to time, and such other powers as may be granted to limited liability companies in the State of Alabama or such other jurisdictions as the Company may be doing business from time to time.
- 4. REGISTERED OFFICE & AGENT. The location and mailing address of the Company's initial registered office 5204 Dunnavant Valley Way, Birmingham, Alabama 35242. The name of the Company's initial registered agent at such address is Neva S. Reardon.
- 5. <u>INITIAL MEMBER(S)</u>. The names and addresses of the initial members of the Company are as follows:

- 6. <u>ADMISSION OF ADDITIONAL MEMBERS</u>. The Member(s) reserve the right to admit additional members upon an affirmative vote by the holders of a majority of the membership interest in the Company as to the admission of, and the consideration to be paid by, such new Members, and otherwise as subject to the terms and conditions of the Company's Operating Agreement.
- Operating Agreement of the Company to regulate or establish the affairs of the Company, the conduct of its business, and the relations of its Members, so long as the provisions regarding the affairs of the Company and the conduct of its business are not inconsistent with the laws of this state of Alabama or this Certificate of Formation. If the Member(s) elects to enter into an Operating Agreement, said Operating Agreement shall be executed by each Member of the Company and shall set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with the Act or this Certificate of Formation.
- 8. <u>CONTINUATION OF BUSINESS</u>. Upon the occurrence of there being no Members, the Company shall be dissolved. Notwithstanding the foregoing, the remaining holders of the membership interest in the Company shall have the right to continue the legal existence and business of the Company and to appoint one or more new Members upon an affirmative vote by the holders of a majority of the membership interest in the Company.
- 9. <u>LIABILITIES OF MEMBERS</u>. Members of the Company are not liable under any judgment, decree or order of a court, or in any other manner, for any debt, obligation, or liability of the Company.
- 10. <u>MANAGEMENT</u>. The management of the Company shall be managed by the Members pursuant to Alabama law. If the Member(s) elects to enter into an Operating Agreement, the Member(s) shall manage the Company pursuant to the terms of Alabama law and the Operating Agreement.


