**KNOW ALL MEN BY THESE PRESENTS**, That in consideration of the sum of Two-hundred eighteen thousand (\$218,000.00) dollars paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Samuel John Makofski and wife, Patricia M. Makofski (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Leslie B. Markham and Elishua Markham (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 55, according to the Survey of Lacey's Grove, Phase 1, as recorded in Map Book 35, Page 137, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

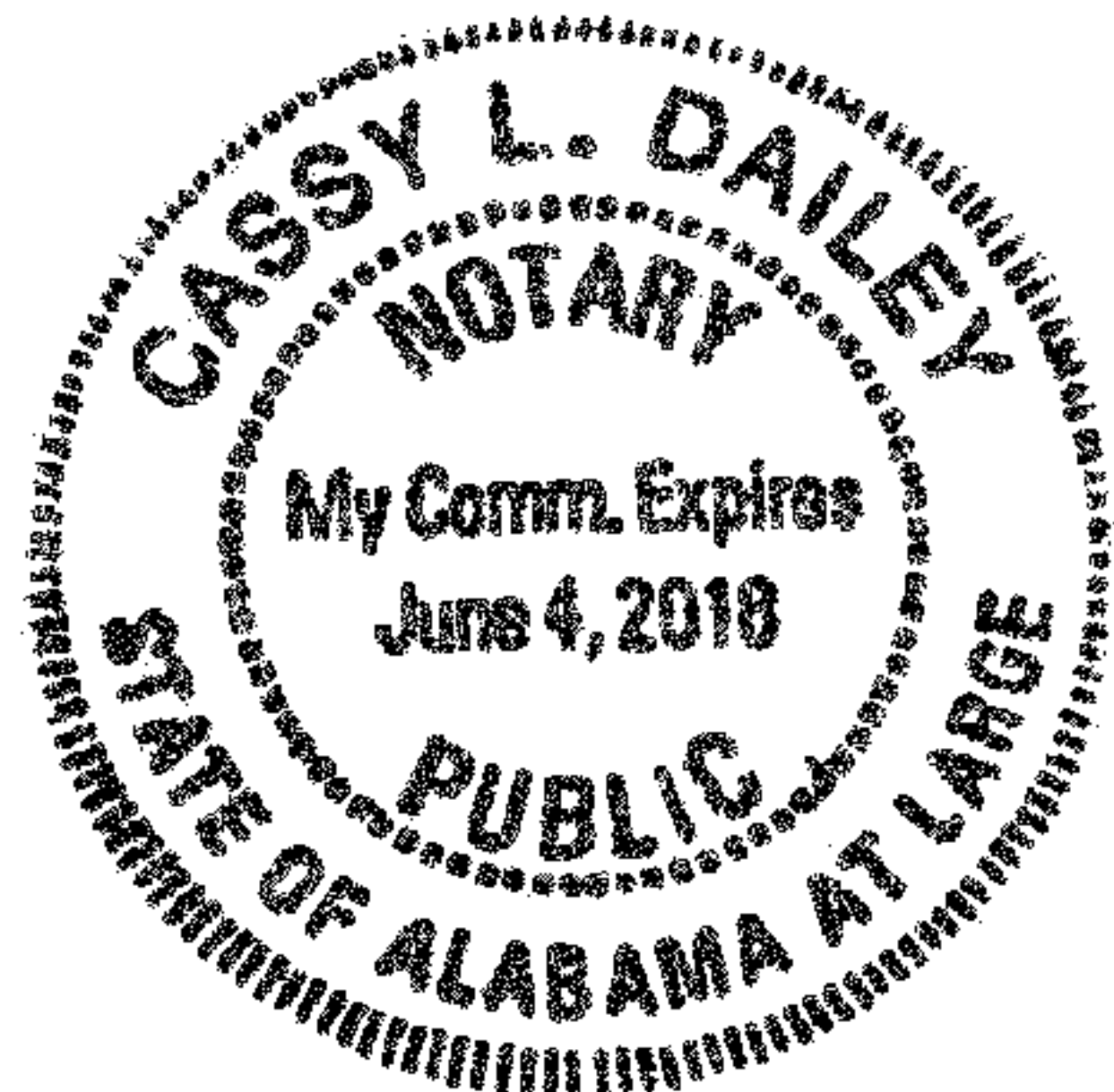


