KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 10th day of June, 2013, Myra Williams, a married person, and Stefan J. 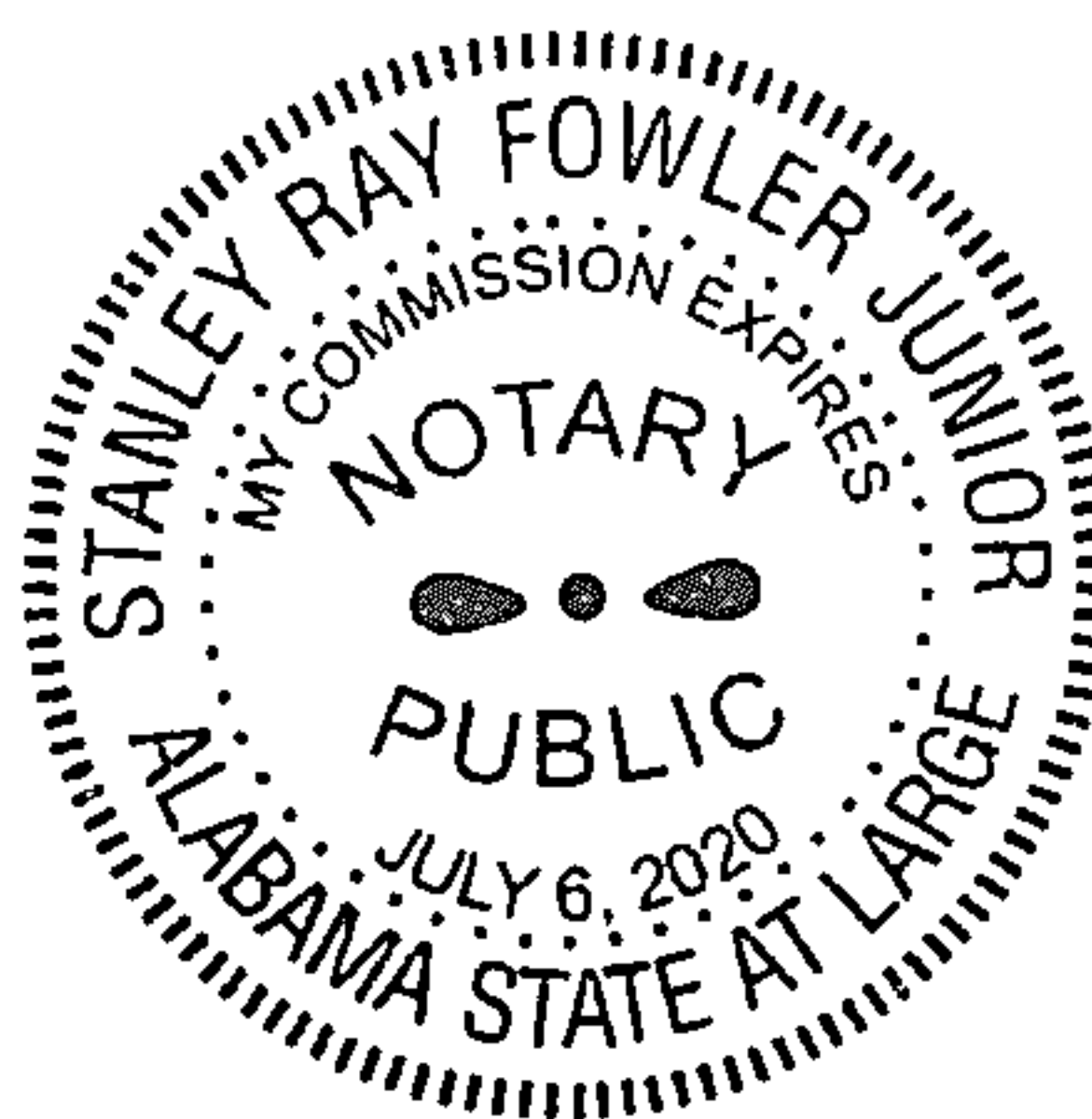
