That in consideration of **Four Hundred Thirty Eight Thousand and 00/100 Dollars (\$438,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

**Jeffrey R. Dixon, and his wife, Amanda O. Dixon**

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

**George W. Riddle, Jr. and Mary F. Riddle**

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:



