Thence run S 31° 19' 28" W for a distance of 398.43 feet to a point;

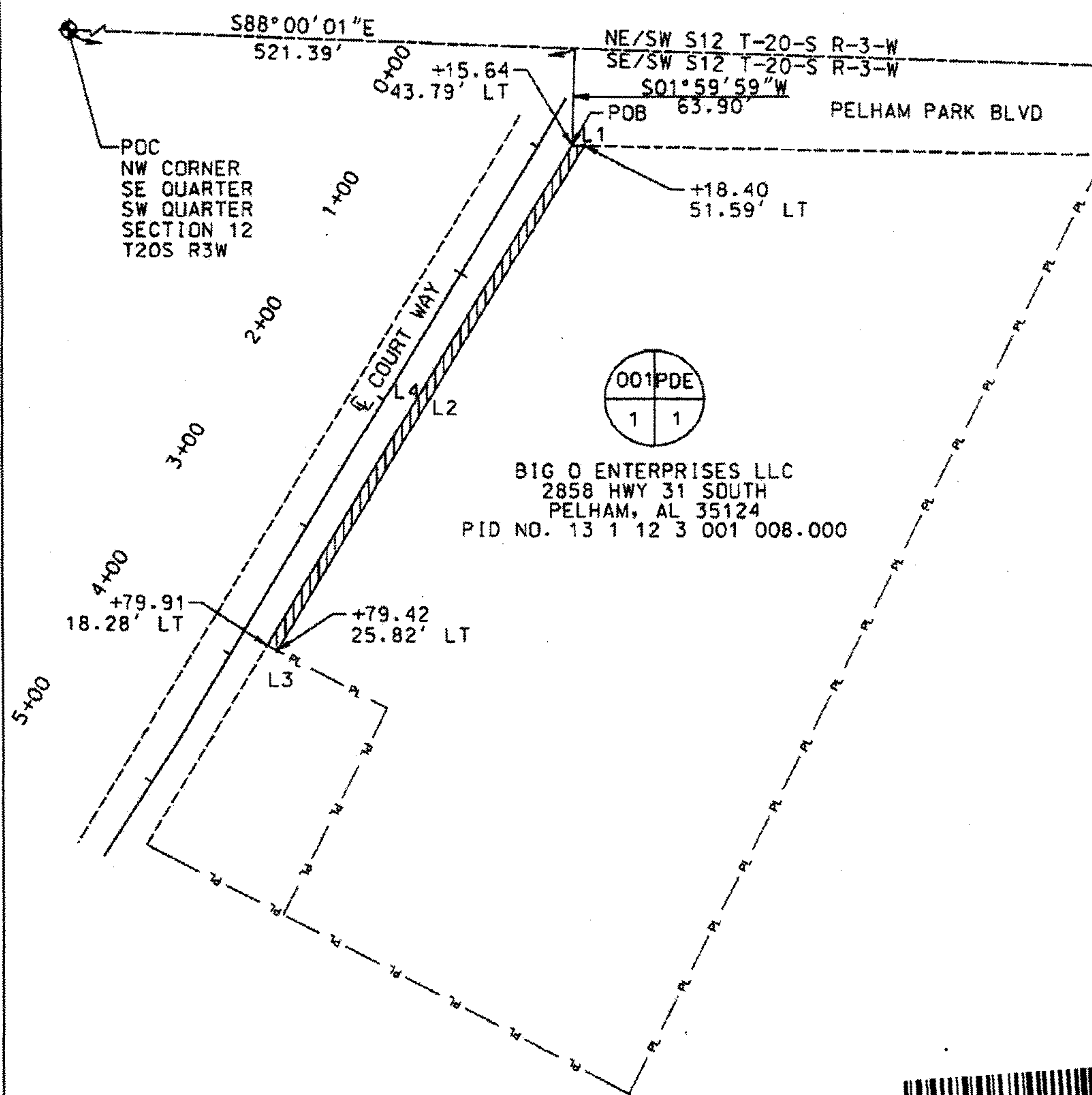
Thence run N 62° 33' 55" W for a distance of 7.56 feet to a point on the eastern right-of-way line of Court Way to a point;
