Thence run S 29° 29' 28" W for a distance of 155.02 feet to a point;

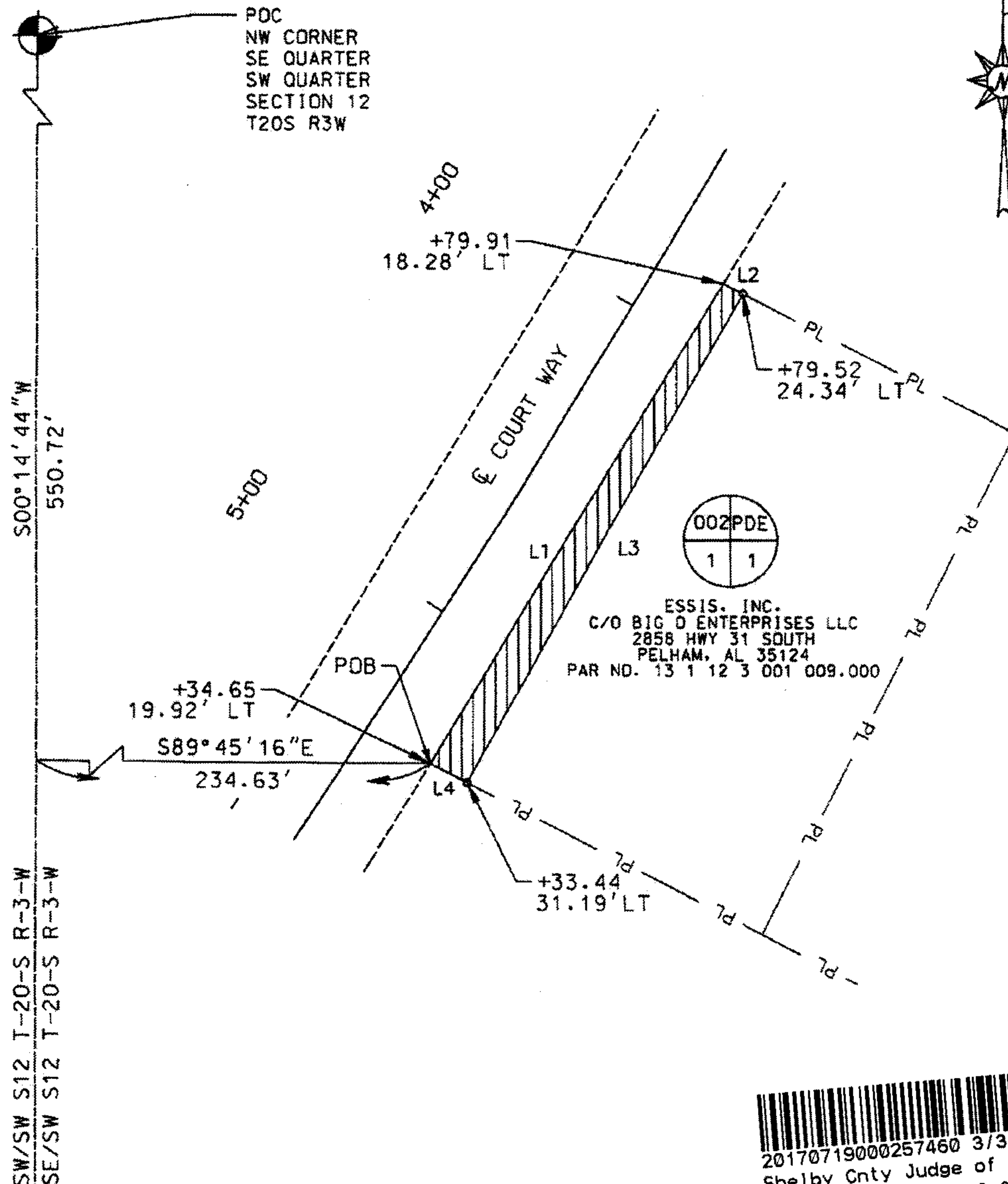
