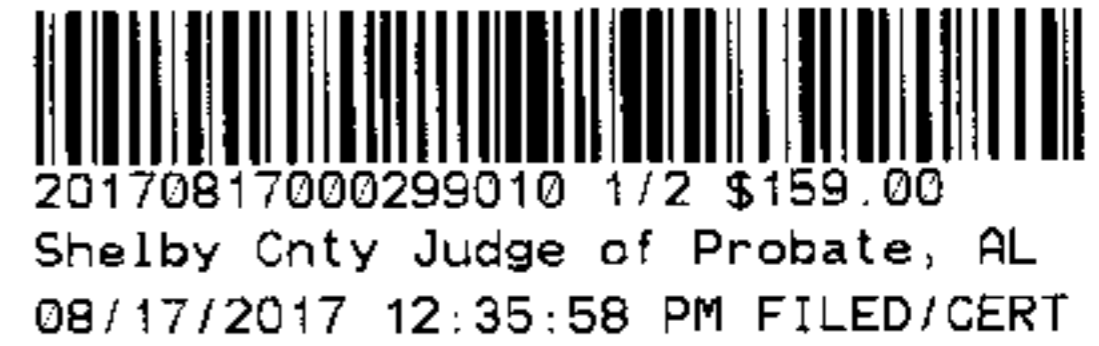


**CERTIFICATE OF FORMATION

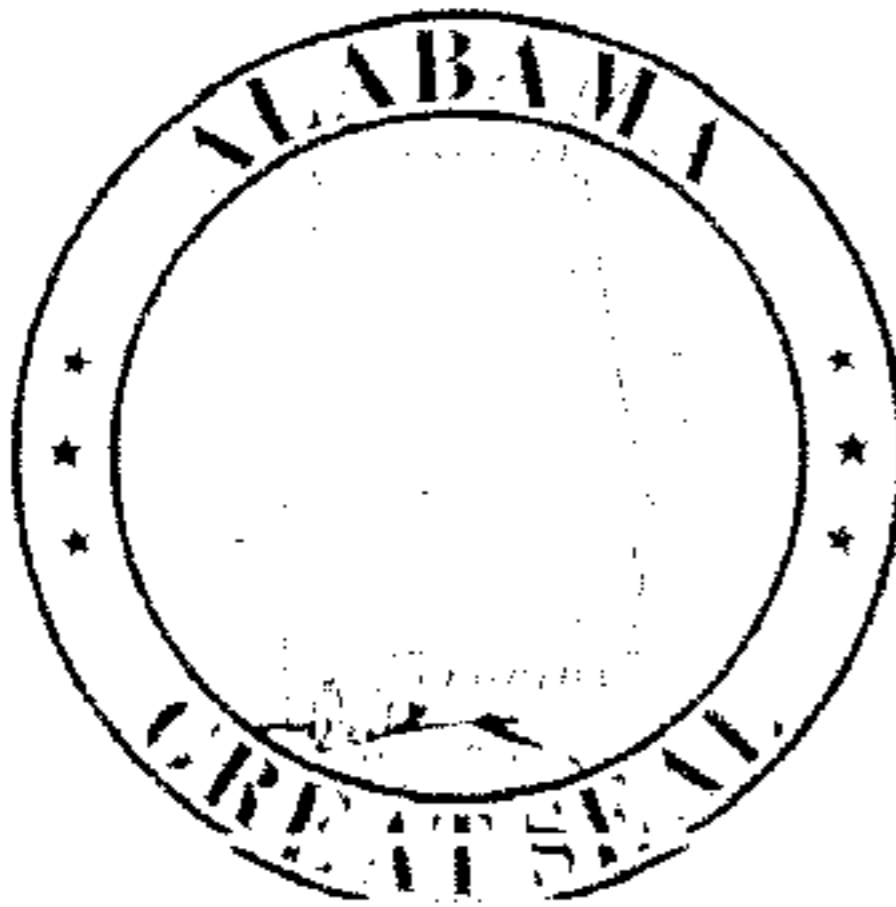
