10. Subject to 55 foot building setback line from Hollow Log Road; 10 foot easement along rear lot line, as shown on recorded plat.

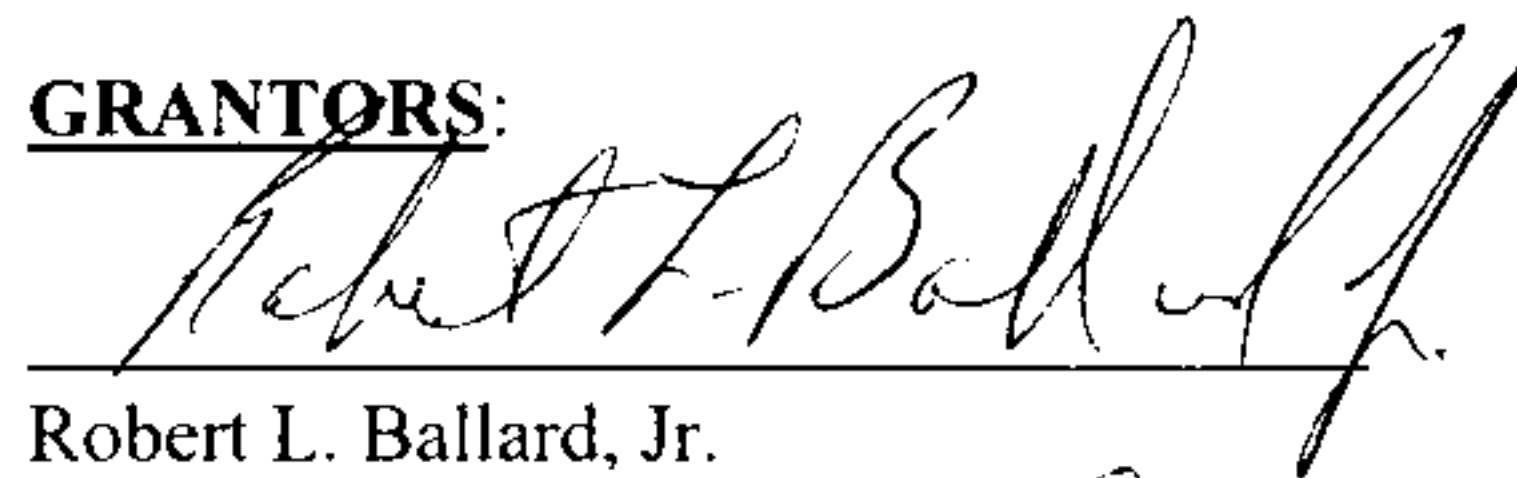

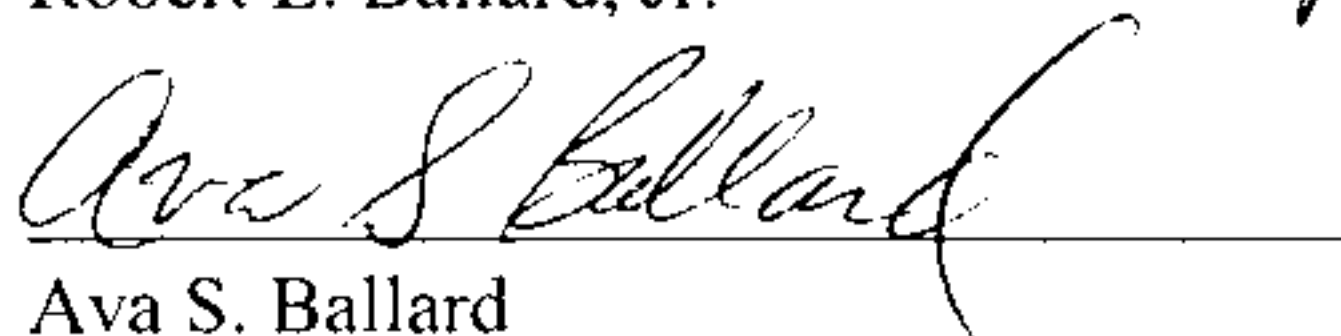

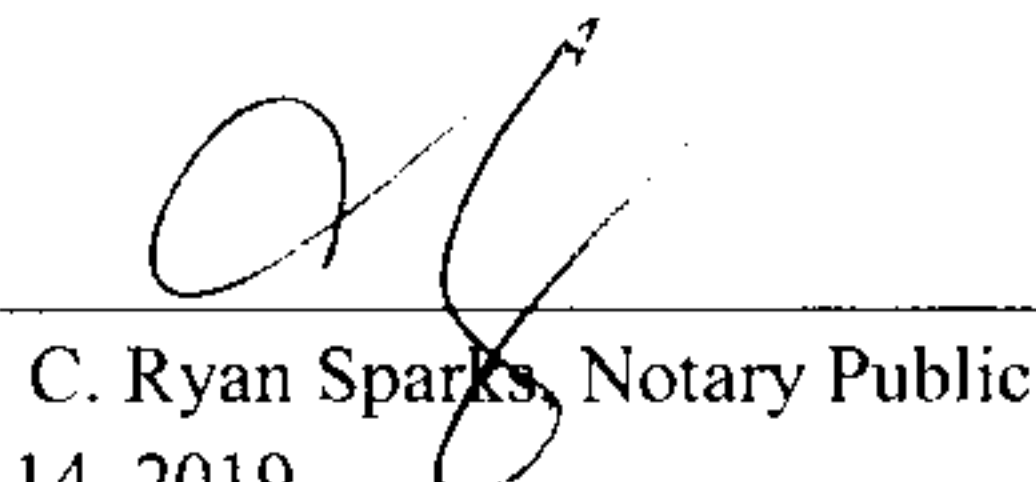
