**ARTICLES OF INCORPORATION
OF

The undersigned incorporators do hereby form a corporation under the Alabama Business Corporation Law, and do declare:

ARTICLE I
NAME

The name of the Corporation shall be Data Link Communications, Inc.

ARTICLE II
TYPE OF ENTITY

The type of entity being formed is a business corporation.

ARTICLE III
PURPOSES

The purposes for which this Corporation is organized are:

- (a) To provide information technology support and set up for telephone, computer and surveillance system networks.


ARTICLE VIII
