Know All Men by These Presents: That in consideration of **One Hundred Thirty-Two Thousand and no/100 Dollars (\$132,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, I, **SHAWN P. RIMEL, a married man** (herein referred to as Grantor) grant, bargain, sell and convey unto **NEUBURN D. EDWARDS and ENDA I. EDWARDS** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:


