The Association claims a lien upon property owned by **Thomas Mitchell & Sharon Ogletree** situated in Shelby County, Alabama described as follows:

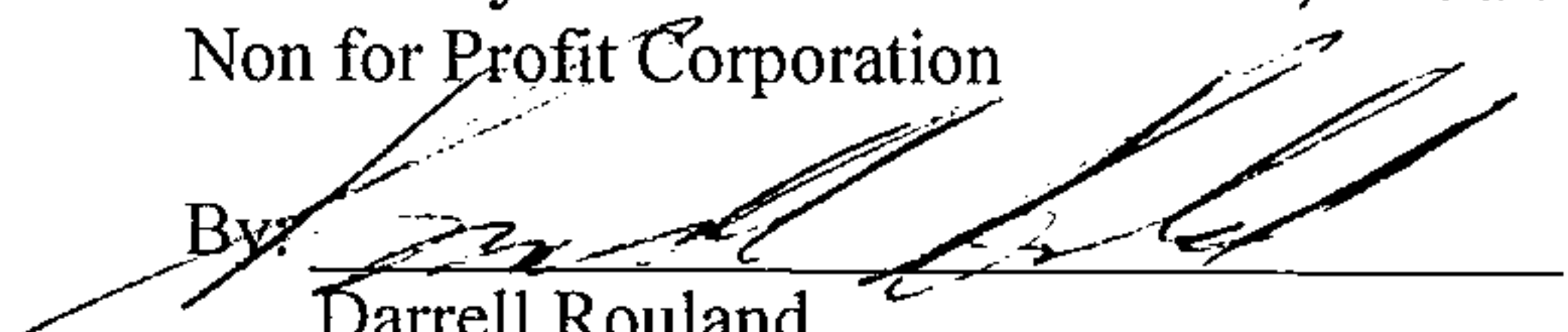

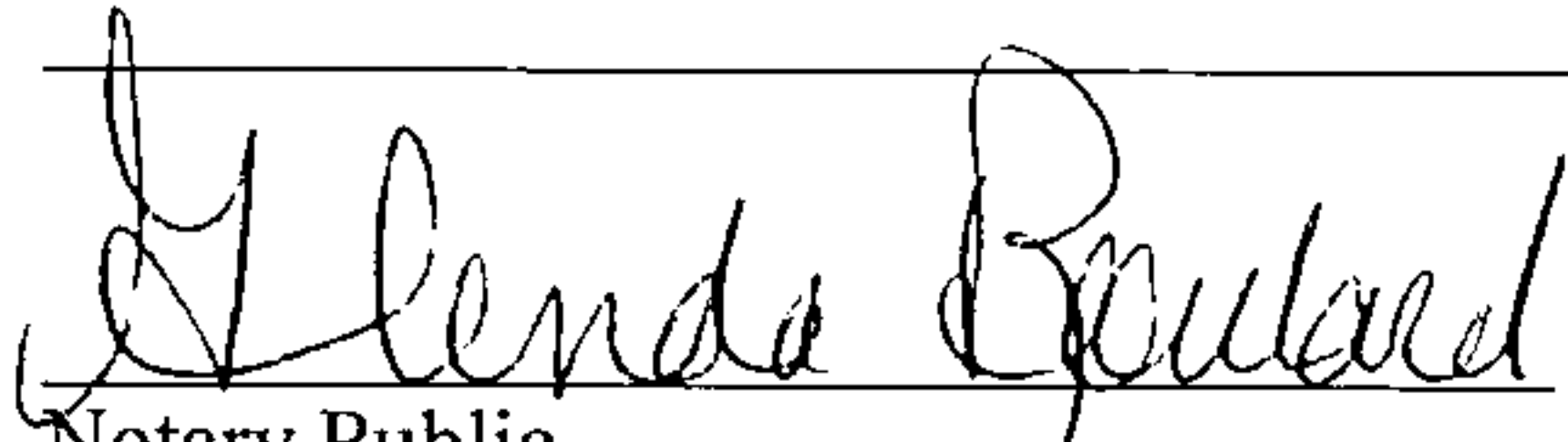
