

**ARTICLES OF ORGANIZATION OF

Comes now the undersigned natural person of age, nineteen years or more, acting as organizer of a limited liability company under the Limited Liability Company Act of the State of Alabama, hereby adopt the following Articles of Organization for the limited liability company:

**ARTICLE ONE**
