The Association claims a lien upon property owned by **Torrey & Tina Rice**, situated in Shelby County, Alabama described as follows:





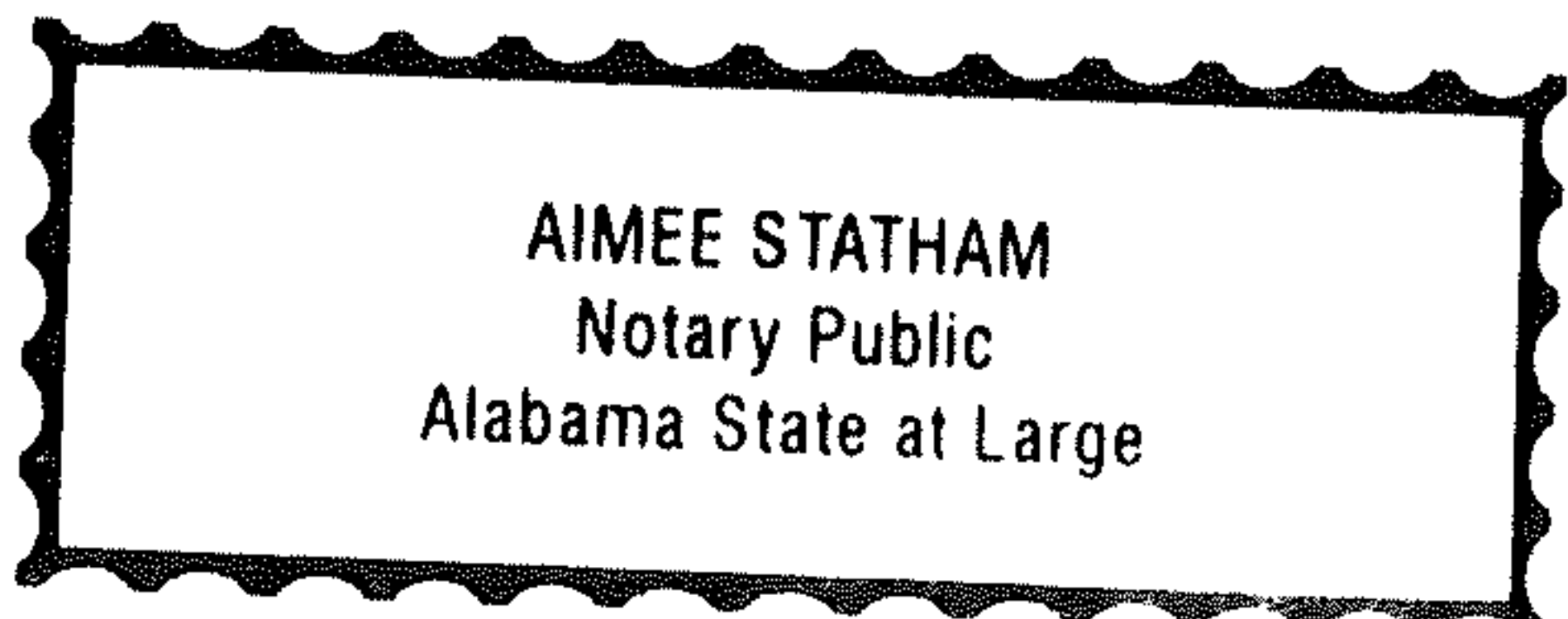
