**ARTICLE I**

***Name***

The name of the limited liability company is AFK Properties, LLC (the "Company").

The reason for dissolution of AFK Properties, LLC are as follows:

### *Indebtedness of AFK Properties , LLC*



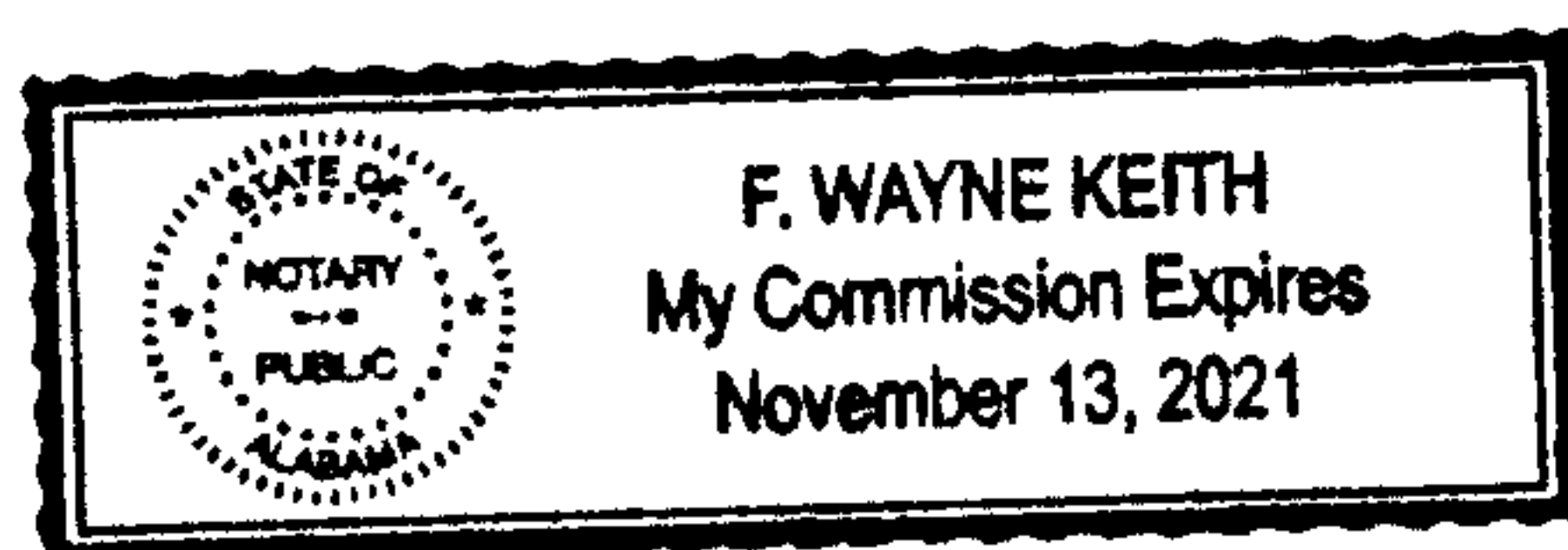


