ARTICLES OF ORGANIZATION
OF
AH Holdings, LLC

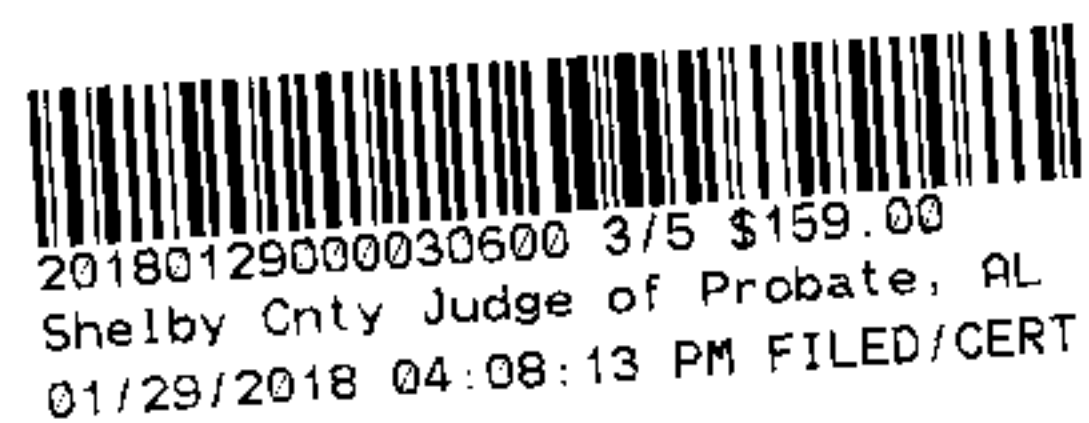
The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Act (the Act), hereby adopt the following Articles of Organization for **AH Holdings, LLC**

1. The name of the Limited Liability Company is **AH Holdings, LLC**.
2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate in Shelby County, Alabama, and shall continue until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement governing the duration of the company, then in accordance with the Alabama Limited Liability Company Act.
3. The purpose for which this Limited Liability Company is organized is:

To engage in the transaction of any or all lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama.
4. The location and mailing address of the initial registered office shall be: 4898 Valleydale Rd., Suite A4, Birmingham, AL 35242, and the name of the initial registered agent at said address shall be Jordan Huffstetler.
5. The names and mailing addresses of the initial members of the Limited Liability Company is as follows:

6. The members of the Limited Liability Company shall have the right to admit additional members to the Limited Liability Company upon the unanimous consent of all the members of the Limited Liability Company.
7. The remaining members of the Limited Liability Company shall have the right to continue the legal existence and business of the Limited Liability Company after an event of dissociation (as set forth in the operating agreement,



if any) terminates the continued membership of a member in the Limited Liability Company if: (i) there are at least two remaining members, or at least one remaining member and a new member is admitted; and (ii) the legal existence and business of the Limited Liability Company is continued by the written consent of a majority interest of the remaining members within 90 days after the occurrence of the event of dissociation. For the purposes of this provision, a majority of interest of the remaining members means interests of one or more remaining members which, when taken together, exceeds fifty percent (50%) of the capital interests and fifty percent (50%) of the profits interests of the remaining members.

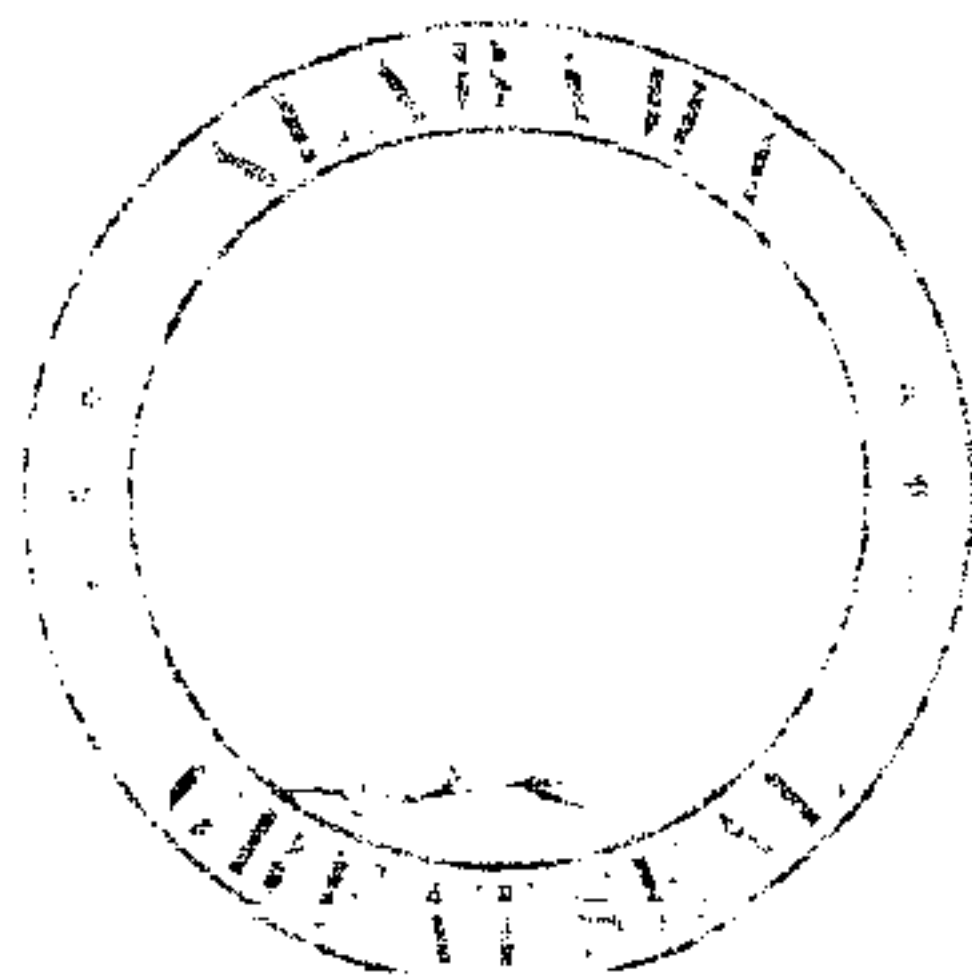
