

## ORDINANCE NO. 135-215

AN ORDINANCE OF THE CITY OF PELHAM, PROVIDING THAT THE CODE OF ORDINANCES, CITY OF PELHAM, ALABAMA, BE AMENDED BY ADDING A SECTION TO BE NUMBERED 135-215 PROVIDING THE FOLLOWING AMENDMENT TO THE ZONING ORDINANCE:

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA AS FOLLOWS:**

**SECTION ONE:** The rezoning of property located at Highway 33 – West of Interstate 65, changing the present zoning A-1 Agricultural District to R-1 Residential District.

Applicant: Pelham Board of Education

Legal Description:

BEGIN at the NW Corner of the SE 1/4 of the NW 1/4 of Section 7, Township 20 South, Range 2 West, Shelby County, Alabama, said point being the POINT OF BEGINNING; thence S88°35'05"E and along the North line of above said 1/4-1/4, a distance of 650.00'; thence S45°59'52"W, a distance of 912.51' to the West line of above said 1/4-1/4; thence N00°35'20"E and along above said West 1/4-1/4 line, a distance of 650.00' to the POINT OF BEGINNING.

Said Parcel containing 4.85 acres, more or less

**SECTION TWO:** All ordinances or parts of ordinances, in any manner conflicting herewith are hereby repealed.

**SECTION THREE:** This ordinance shall become effective on the 24th day of January 2018.

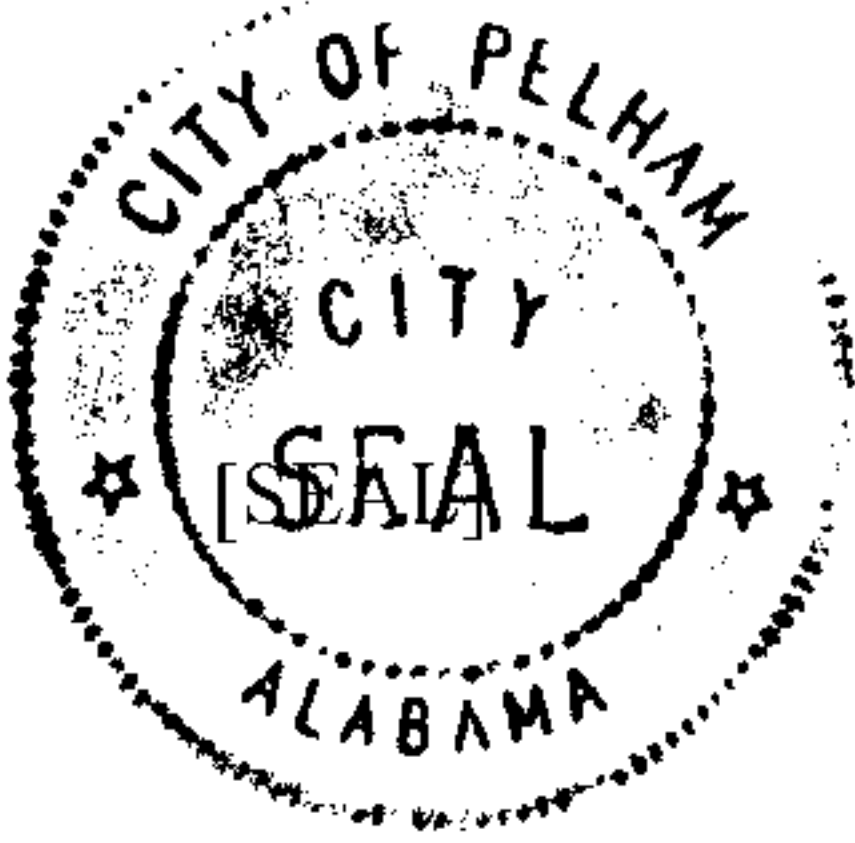
