

**DOMESTIC LIMITED LIABILITY COMPANY**  
**ARTICLES OF ORGANIZATION**

Pursuant to the provisions of the Alabama Limited Liability Company Act, §10-12-1 et. seq., Code of Alabama (1975), as amended, the undersigned hereby adopts the following Articles of Organization:

**ARTICLE I**

The name of the Limited Liability Company shall be: **Fit 24 Clubs, L.L.C.**

**ARTICLE II**

The period of duration shall be: **Fifty (50) years from and after the date of the formation of the Limited Liability Company unless the Limited Liability Company is earlier dissolved in accordance with either the provisions of the operating agreement or of the Alabama Limited Liability Company Act.**

**ARTICLE III**

The Limited Liability Company has been organized for the following purposes:

- A) Managing and operating Fitness Centers; and,**
- B) Any other lawful purpose or purposes.**

**ARTICLE IV**

The location and street address of the initial registered office shall be:

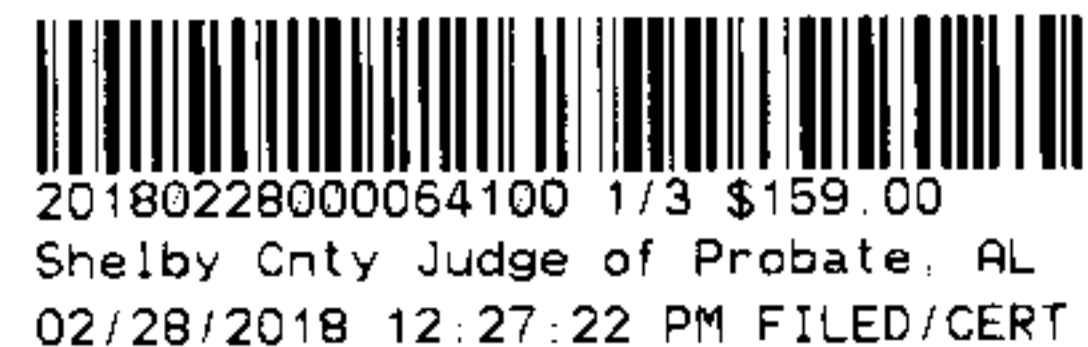

ARTICLE VII


Subject to contrary provisions in the operating agreement, the cessation of membership of the initial Member shall result in dissolution of the Limited Liability Company.

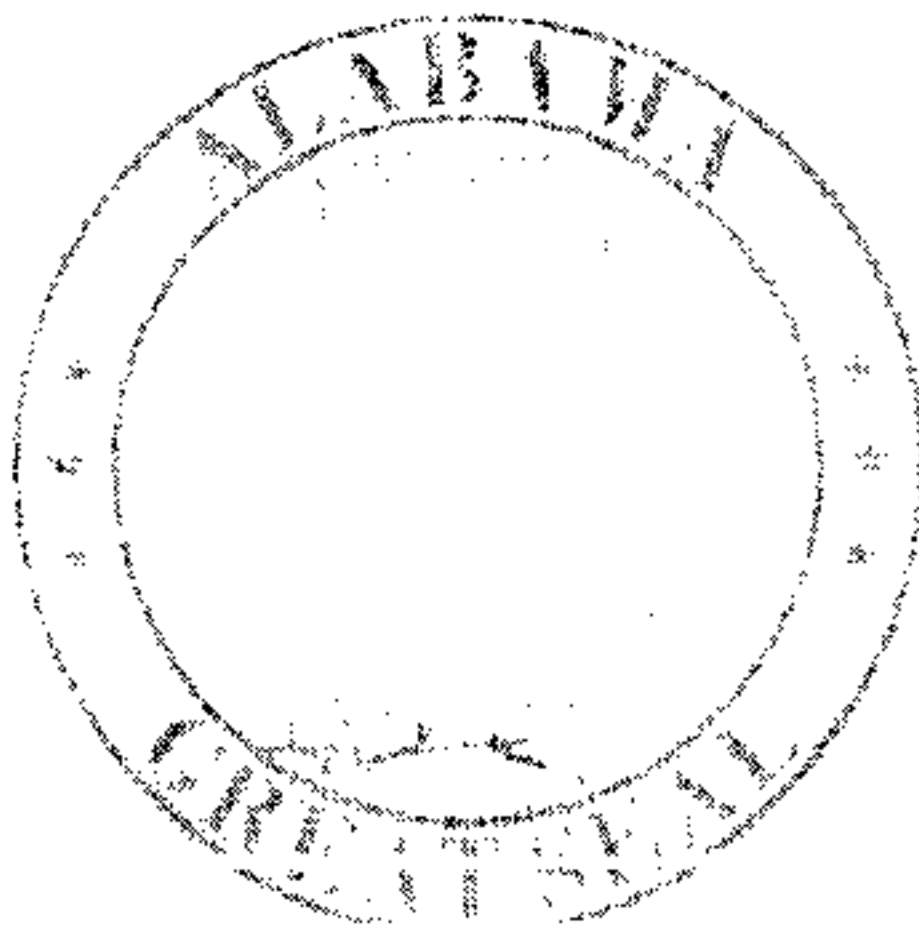
