WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **ONE HUNDRED SEVEN THOUSAND FIVE HUNDRED AND NO/100 (\$107,500.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **WILLIAM C. KUEHNER and LINDSAY P. KUEHNER, husband and wife**, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **DAVID ETHRIDGE and JOLENE ETHRIDGE**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 5, according to the subdivision of Yellowleaf Creek Farms, as recorded in Map Book 41, Page 83, in the Probate Office of Shelby County, Alabama.

Subject to:

2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.




