ORDINANCE NO. 135-218

AN ORDINANCE TO AMEND THE CODE OF ORDINANCES, CITY OF PELHAM, ALABAMA, APPENDIX A - ZONING, ARTICLE XXI - CORRIDOR OVERLAY DISTRICT, SECTION 2 - AREAS OF APPLICABILITY

WHEREAS, the City of Pelham has determined that it is in the best interest of the City to amend Appendix A - Zoning, Article XXI - Corridor Overlay District, Section 2 – Areas of Applicability of the Code of Ordinances, City of Pelham, Alabama.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Pelham, Alabama, that Appendix A - Zoning, Article XXI Corridor Overlay District, Section 2– Areas of Applicability of the Code of Ordinances, City of Pelham, shall be amended as follows:

Section 2. - Areas of Applicability. These regulations shall apply to all lots, parcels and tracts that have any frontage upon the following rights-of-ways within the corporate limits of the City of Pelham:

- 1. Alabama State Highway 31
- 2. Alabama State Highway 119
- 3. Alabama State Highway 261
- 4. Amphitheater Road
- 5. Applegate Parkway
- 6. Business Park Drive
- 7. Commerce Boulevard
- 8. Huntley Parkway
- 9. Interstate 65
- 10. Metro Parkway
- 11. Oak Park Drive
- 12. Oak Mountain State Park Road
- 13. Old Montgomery Highway
- 14. Shelby County Highway 11
- 15. Shelby County Highway 17
- 16. Shelby County Highway 35, a distance of .5 miles in a general northerly direction from its intersection with Shelby County Highway 52W
- 17. Shelby County Highway 52
- 18. Southgate Drive

The uses permitted under any zone district classification coupled with the Overlay District are not affected by such overlay district designation. Only the potential development of the subject property is affected.

In the interpretation and application of this section, all provisions shall be:

- (1) Considered as minimum requirements; and (2)
- (2) Substantially construed in favor of the governing body.

Any property developed as single-family residential shall be excluded from the requirements of this section.

- II. The provisions of this Ordinance are severable. If any part of this Ordinance is declared invalid or unconstitutional, that declaration shall not affect the part which remains.
- III. This ordinance shall go into effect upon the passage and adoption by the City Council of the City of Pelham, Alabama and posting as required by law.
