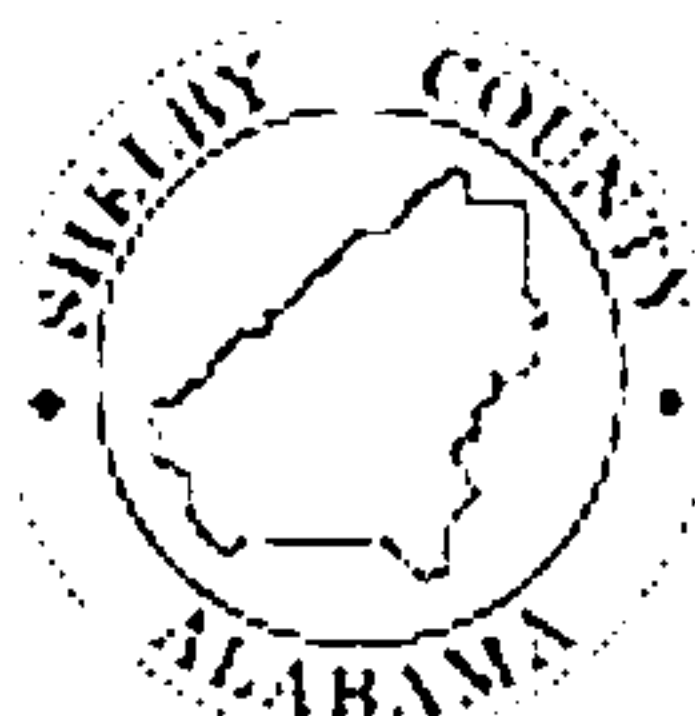

SCRIVENER'S AFFIDAVIT

I, Ginny Rutledge, being duly sworn, depose and state the following:

1. I am an attorney who prepared that certain **Foreclosure Deed** recorded February 11, 2011 in **Instrument number 20110211000049410**, in the Office of the Judge of Probate of Shelby County, Alabama, which evidences the transfer of the hereinafter described real property from Contrena Bozeman (Grantor) to Wells Fargo Bank, N.A.
