MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, December 22, 2014, **Miracle M. Mixon, An Unmarried Woman, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc.**, as nominee for **Hamilton Mortgage Corporation**, its successors and assigns, which said mortgage is recorded in Instrument No. 20141229000407050 as modified by that certain Modification Agreement in Instrument No. 20170331000107410, in the Office of the Judge of Probate of Shelby County, Alabama; and

WHEREAS, on April 16, 2018, the day on which the foreclosure sale was due to be held under the terms of said notice at 11:08 o'clock am, between the legal hours of sale, said foreclosure was duly and properly conducted and **LAKEVIEW LOAN SERVICING, LLC** did offer for sale and sell at public outcry, in front of the main entrance of the courthouse door of the Shelby County, Alabama Courthouse, in the City of Helena, Alabama, the property hereinafter described; and

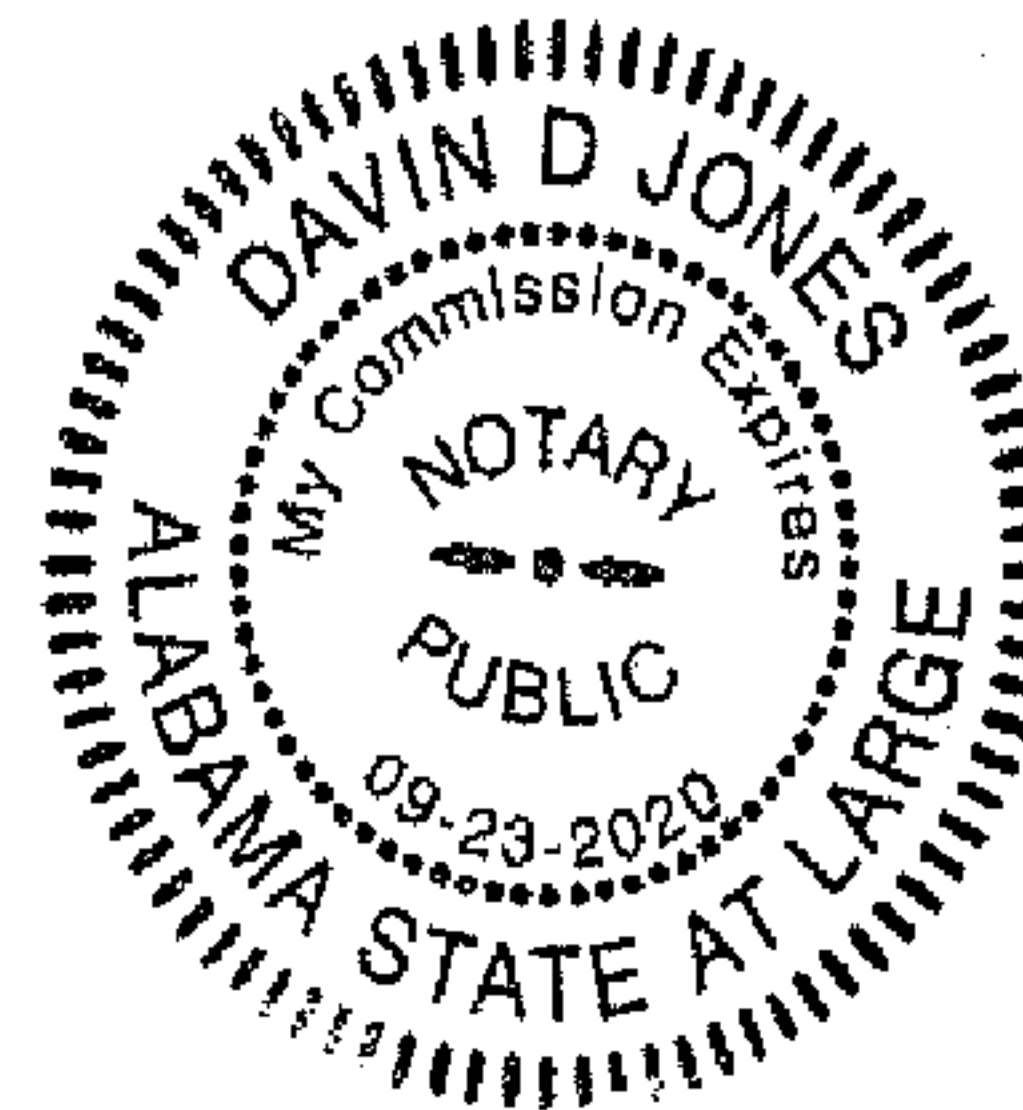
