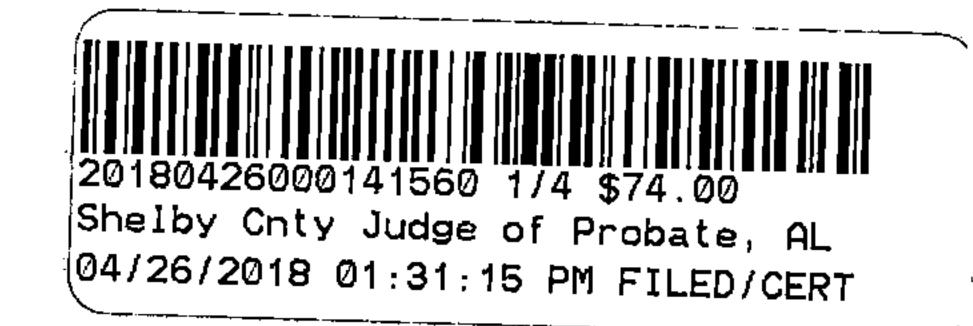

STATUTORY WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that in consideration of Fifty Thousand and No/100 Dollars (\$50,000.00) to the undersigned grantor, 4G BP 2017, LLC, an Alabama limited liability company, (herein referred to as "Grantor"), in hand paid by Grantee named herein, the receipt of which is hereby acknowledged, the said 4G BP 2017, LLC, an Alabama limited liability company, does by these presents, grant, bargain, sell and convey unto EMBASSY HOMES, LLC, an Alabama limited liability company, (hereinafter referred to as "Grantees"), the following described real estate (the "property"), situated in Shelby County, Alabama, to-wit:
