**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS, That in consideration **THIRTY SEVEN THOUSAND DOLLARS AND NO/00 DOLLARS (\$37,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Elwyn Bearden and Debby Bearden, husband and wife** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **David Hilliard and Lindy Hilliard** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

*Lot 1, according to the survey of Ned Bearden Family Subdivision, as recorded in Map Book 49, Page 29, Probate Office, Shelby County, Alabama.*

**SUBJECT TO:**

1. Ad valorem taxes due and payable October 1, 2018.
2. Easements, restrictions, rights of way, and permits of record, including mineral and mining rights.
3. Property constitutes no part of the homestead of the Grantor herein or his spouse.

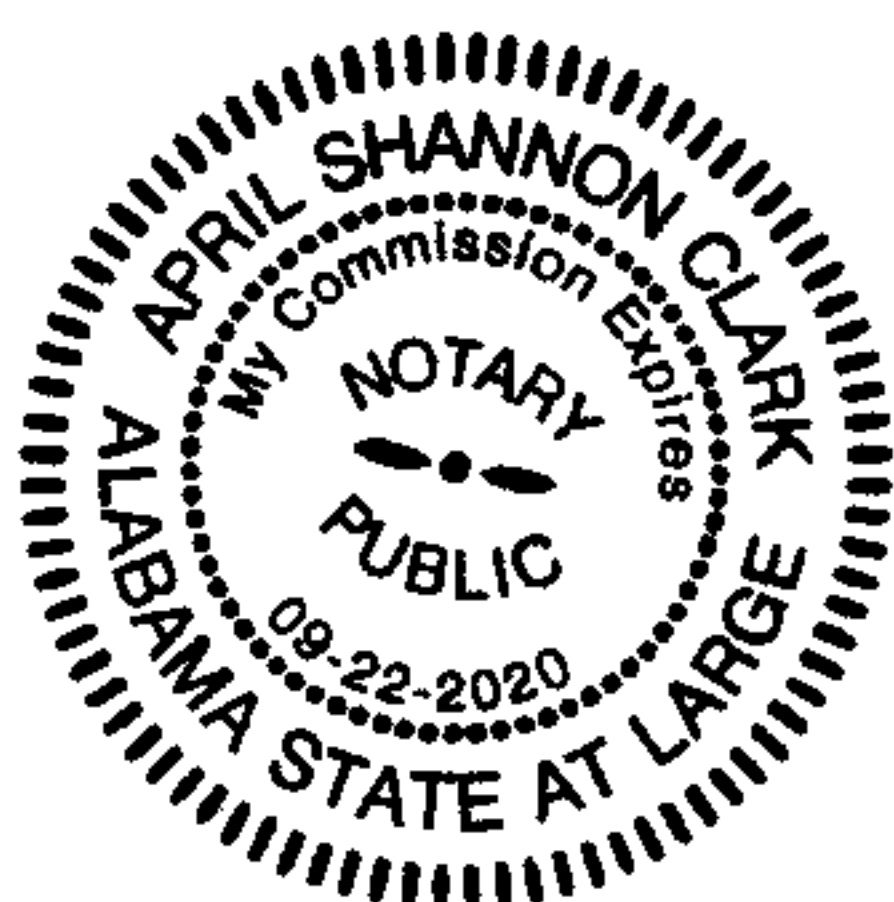
