(hereinafter referred to as "Grantor") does grant, bargain, sell and convey unto

Daedra King

(hereinafter referred to as "Grantee") the following described real estate situated in Shelby County, Alabama to-wit:

Lot 84, according to the Survey of Final Plat Shiloh Creek Sector One Phase II, as recorded in Map Book 42, Page 43, in the Probate Office of Shelby County, Alabama.

\$112,624.68 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to:

- (1) 2018 ad valorem taxes not yet due and payable;
- (2) all mineral and mining rights not owned by the Grantor; and
- (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


TO HAVE AND TO HOLD unto Grantee, her heirs and assigns, forever.



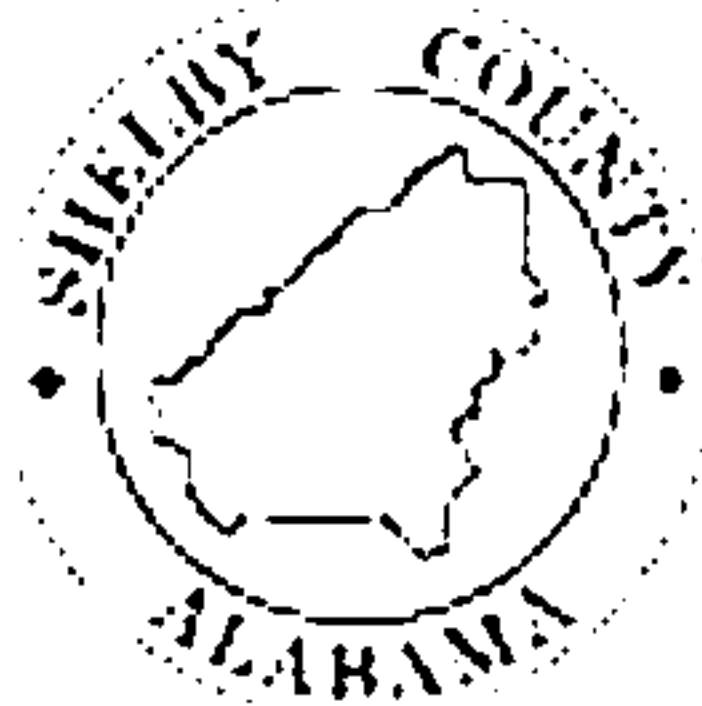
