SUBJECT PARCEL DESCRIPTION

A parcel of land situated in the South  $\frac{1}{2}$  of the SE  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of Section 1, Township 20 South, Range 2 East, Shelby County, Alabama, and being more particularly described as follows:

Commence at a  $\frac{3}{4}$ " rebar at the NE corner of the South  $\frac{1}{2}$  of the SE  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of Section 1, Township 20 South, Range 2 East, Shelby County, Alabama; thence run along the North line of the South  $\frac{1}{2}$  of the SE  $\frac{1}{4}$  of the NW  $\frac{1}{4}$  of said Section 1, S 89°12'45" W a distance of 950.92' to a capped rebar stamped "Landmark" set at the Point of Beginning of the described parcel; thence continue along said North line, S 89°12'45" W a distance of 105.66' to a capped rebar stamped "Landmark" set; thence leaving said North line, S 02°01'45" W a distance of 341.18' to a capped rebar stamped "Landmark" set; thence N 88°54'27" E a distance of 280.42' to a capped rebar stamped "Landmark" set; thence N 25°45'26" W a distance of 374.26' to the Point of Beginning.

The described parcel contains 1.51 acres, more or less.
