KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **Four Hundred Fifteen Thousand and 00/100 (\$415,000.00)**, and other good and valuable consideration, this day in hand paid to the undersigned **Cornerstone Building, LLC, an Alabama limited liability company** (hereinafter referred to as GRANTOR), in hand paid by the GRANTEE herein, the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEE, **Glen A. McCord and Trisha N. McCord** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 224, according to the Survey of Shadow Oak Estates 2nd Sector, as recorded in Map Book 33, Page 149, in the Probate Office of Shelby County, Alabama.

Subject To:

\$373,500.00 of the consideration was paid from the proceeds of a mortgage loan closed simultaneously herewith.


