Ward and Amy S. Ward**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **William D. King and Patty L. 
Property may be subject to all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

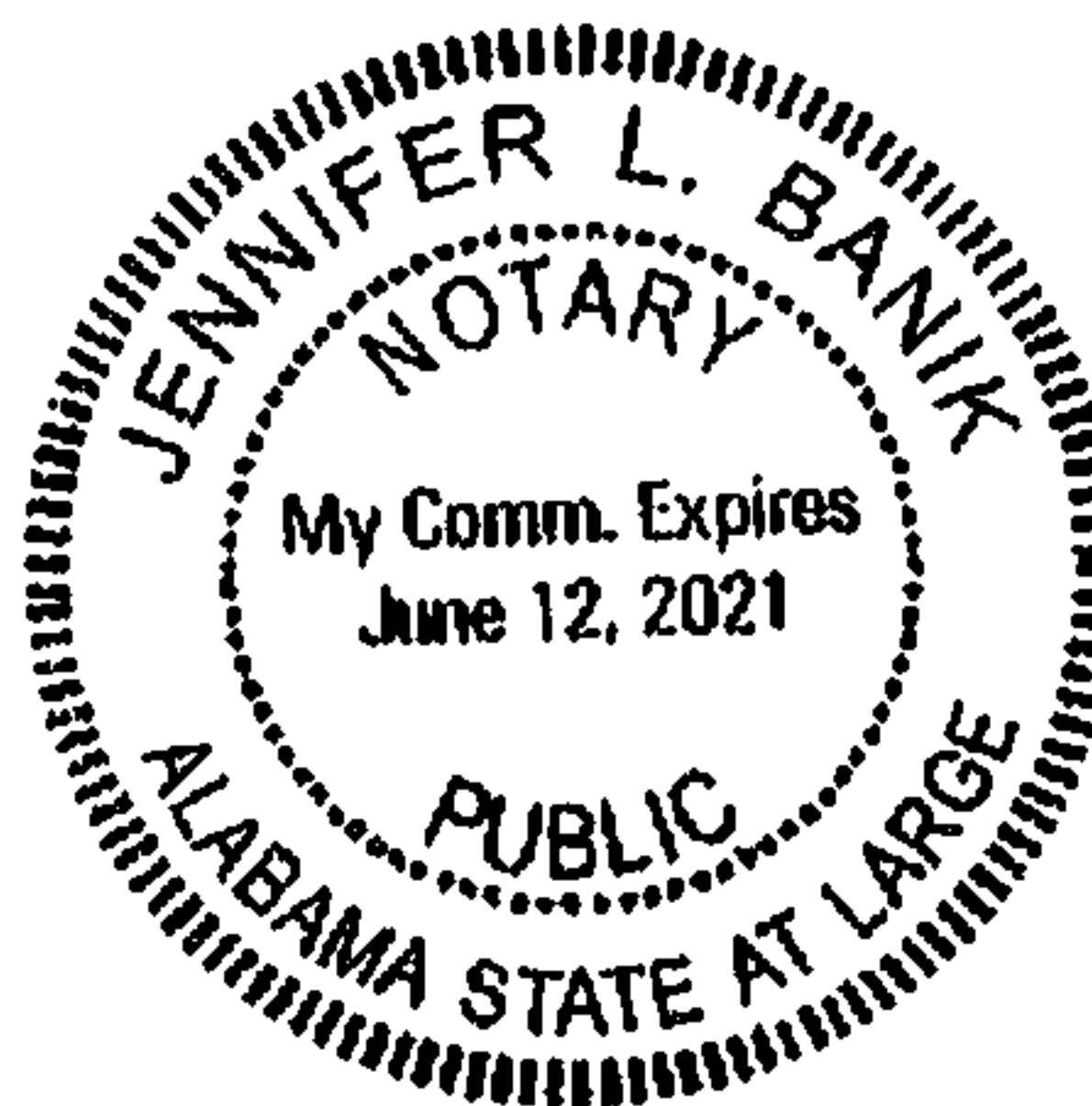
