**CERTIFICATE OF FORMATION
OF

Pursuant to the Provisions of Section 10A-5A-1.01, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

ARTICLE I
