The Association claims a lien upon property owned by Courtney Olsen , situated in Shelby County, Alabama described as follows:

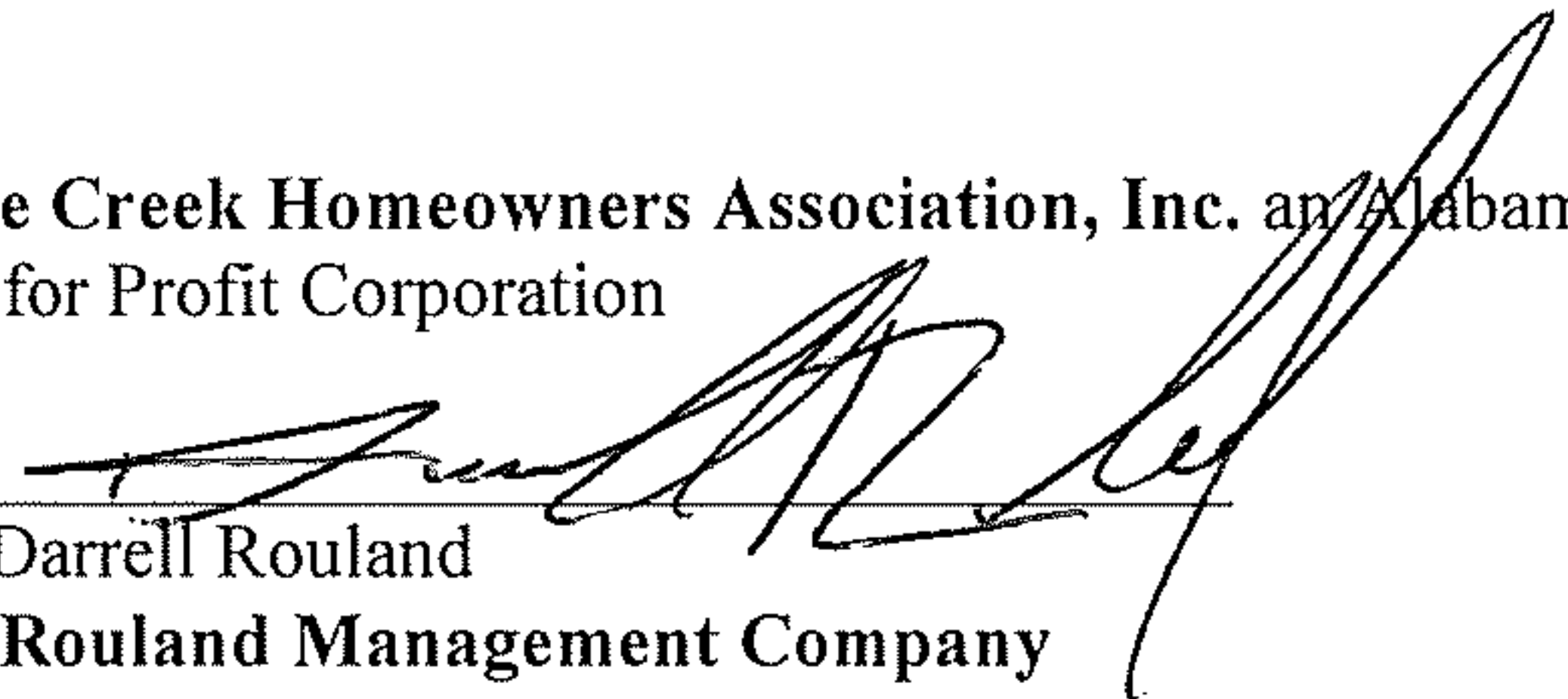

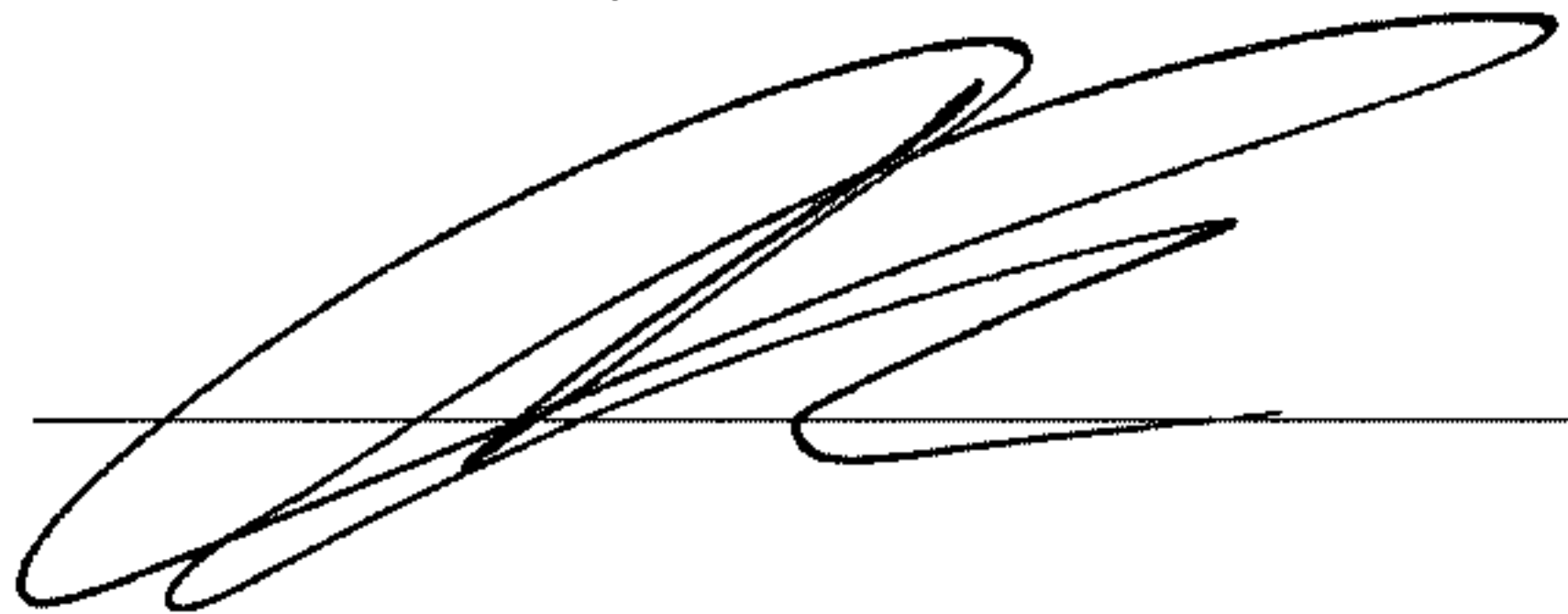

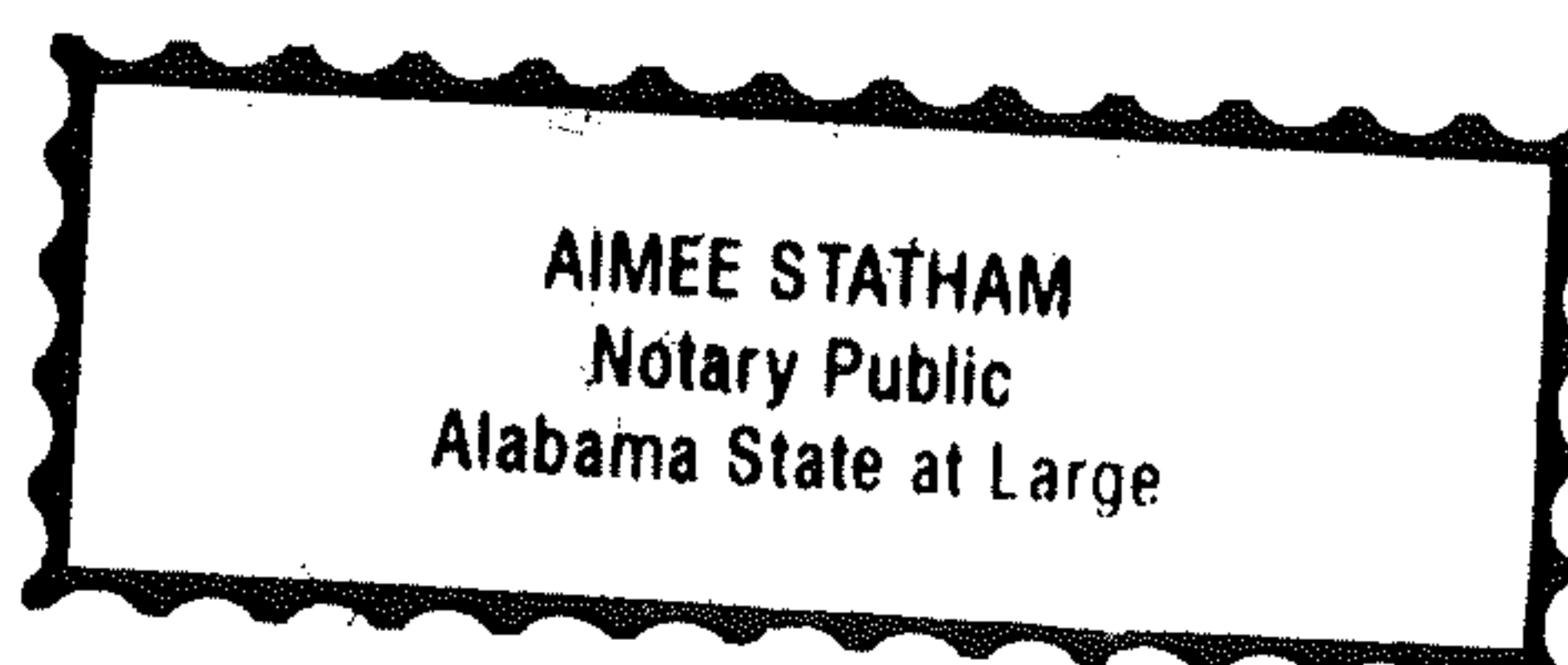
