

**CERTIFICATE OF FORMATION OF
KINGDOM LAND DEVELOPMENT , LLC,
AN ALABAMA LIMITED LIABILITY COMPANY**

Pursuant to the Provisions of Section 10A-5A-2.01 to 10A-5A-2.06, *Code of Alabama* (1975), the undersigned being a natural person of at least 18 years of age and acting as the organizer of the limited liability company hereby being formed hereby adopts the following Certificate of Formation for the limited liability company.

ARTICLE I

Name

The name of the limited liability company is Kingdom Land Development, LLC ("the company").

ARTICLE II

Duration

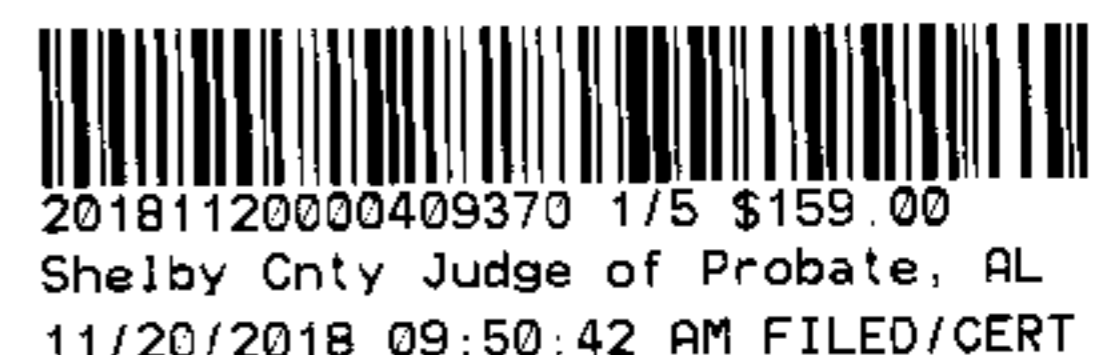
The company shall have a perpetual duration from the date of formation, unless it is (a) terminated by the occurrence of an event set forth in the Operating Agreement and/or (b) dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act.

ARTICLE III

Purposes

The purposes for which the company is formed are:

- (a) To purchase, develop, manage, rent and sell real estate and any lawful act or activity authorized by the laws of the state of Alabama and/or federal law;
- (b) To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, industrial engineering, accounting, bookkeeping and other services of every nature, kind and character, which it may legally render;
- (c) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service, or other lawful business of any kind or character whatsoever;



- (d) To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (e) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (f) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporation, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;
- (g) To lend money, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested; and
- (h) To engage in any other lawful act or activity for which a limited liabilities company may be organized pursuant to and in accordance with Title 10A, Chapter 5A of the *Code of Alabama, 1975*.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the company shall be 121 Bishop Circle, Pelham, Alabama 35124 and its registered agent to whom process may be sent in Alabama at such address shall be Glenn Siddle.

Principal Office

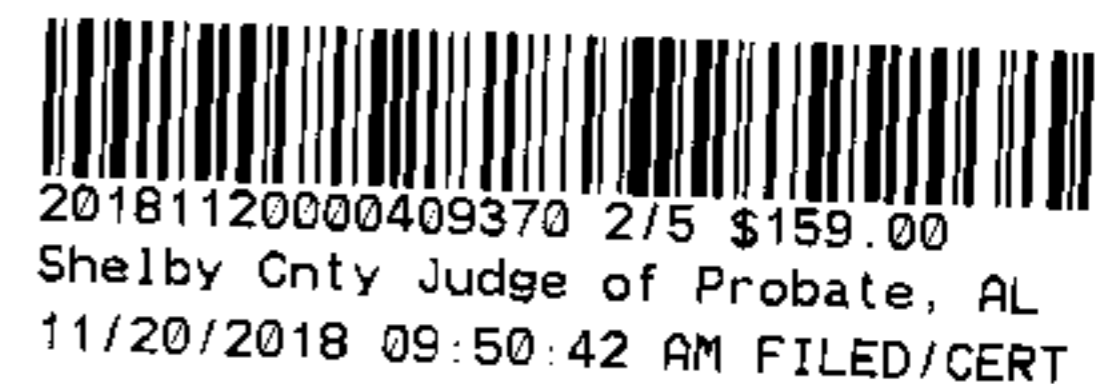

Name and Address of Organizer

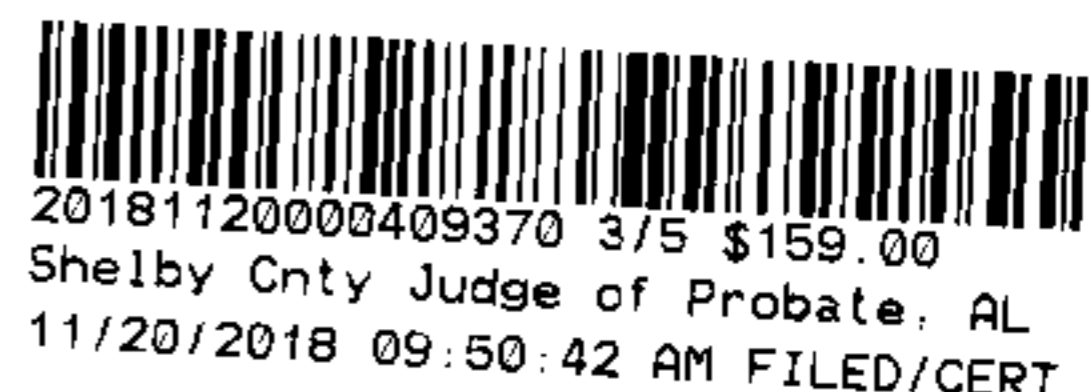

Miscellaneous

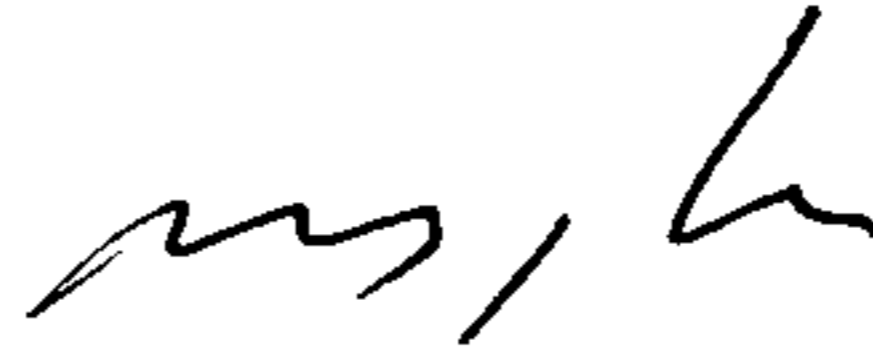
At the date of the filing of this Certificate of Formation, Kingdom Land Development, LLC will have two Members.

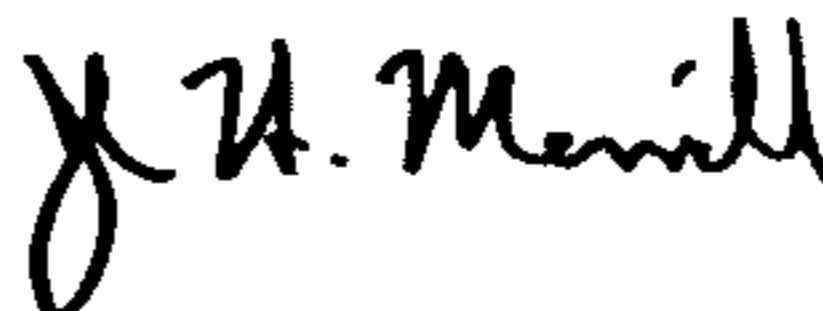
