ORDER

THIS CAUSE, came to be heard August 21, 2018, on Plaintiff's Motion for Default Judgment. Present and appearing on behalf of the Plaintiff was David L. Hubbard. Defendants failed to appear. Upon consideration of the arguments from the Plaintiff's counsel, and pleadings, the Court is of the opinion that the following Order is due to be entered.

This matter has been pending since September 26, 2017. Defendants failed to timely file an Answer, failed to appear at the hearing on August 21, 2018, or otherwise defend against Plaintiff's Complaint. It is hereby **ORDERED, ADJUDGED** and **DECREED**, as follows:

1. The application is **GRANTED** and default against Defendants is hereby entered.
2. Judgment is hereby entered in favor of Plaintiff and against Defendants in the amount of \$162,613.80, inclusive of contract damages (\$127,950.00), pre-judgment interest (\$7,279.50), attorney fees (\$27,045.80), and court costs (\$338.50).
3. Concerning the attorney fee award, separate judgment is entered against Defendants in favor of Plaintiff's undersigned counsel of record, Hubbard Law Firm, for the sum of \$27,045.80, for which execution may issue as allowed by law.
