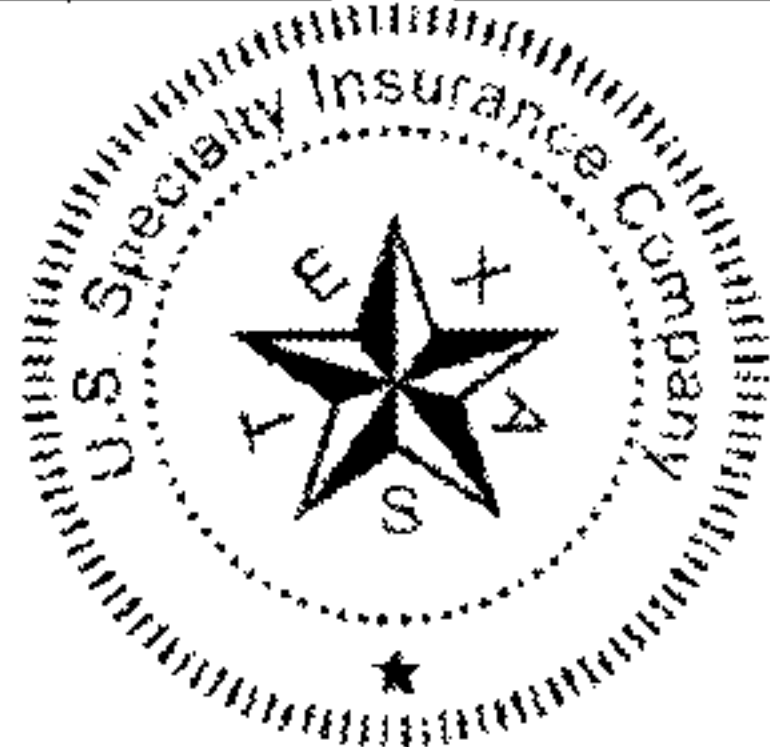

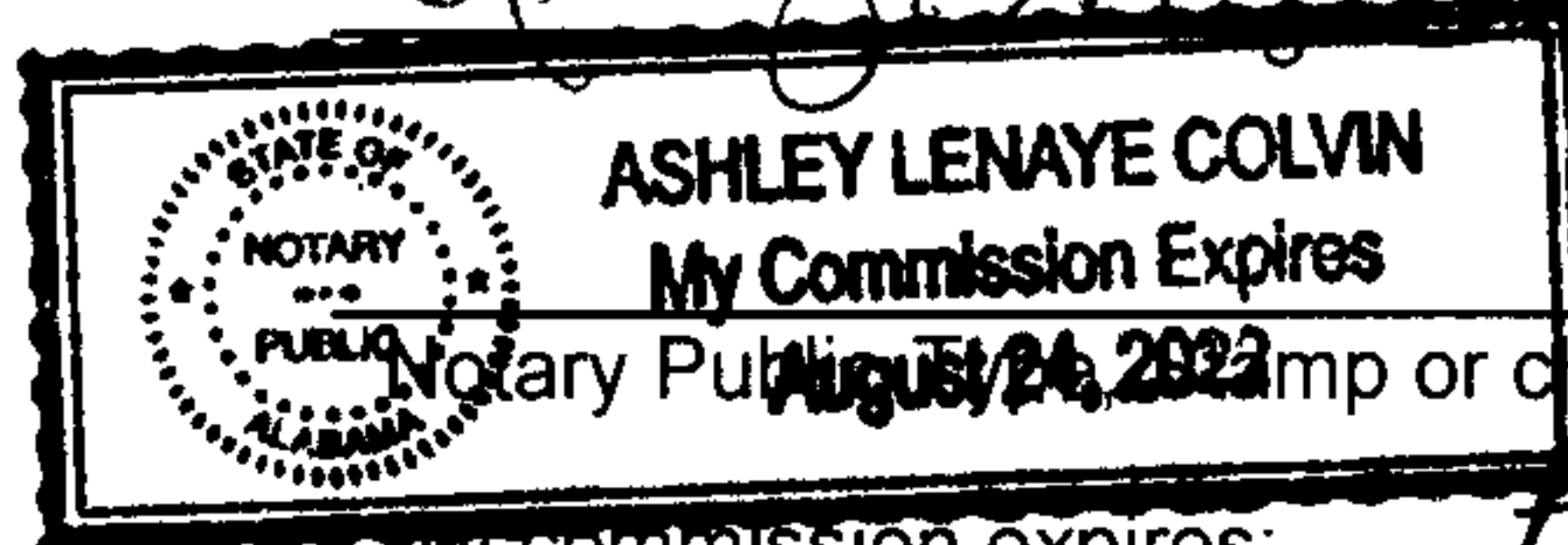

## POWER OF ATTORNEY

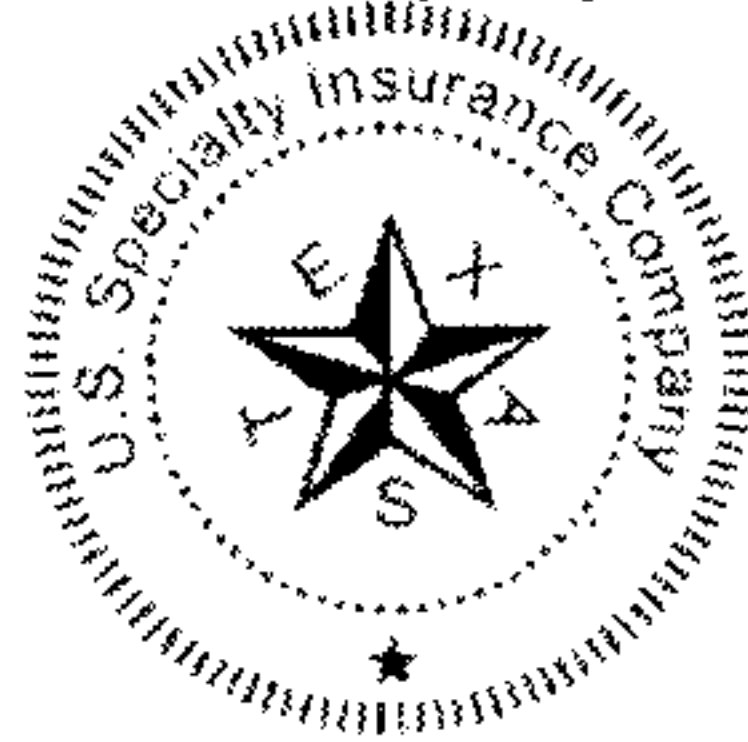

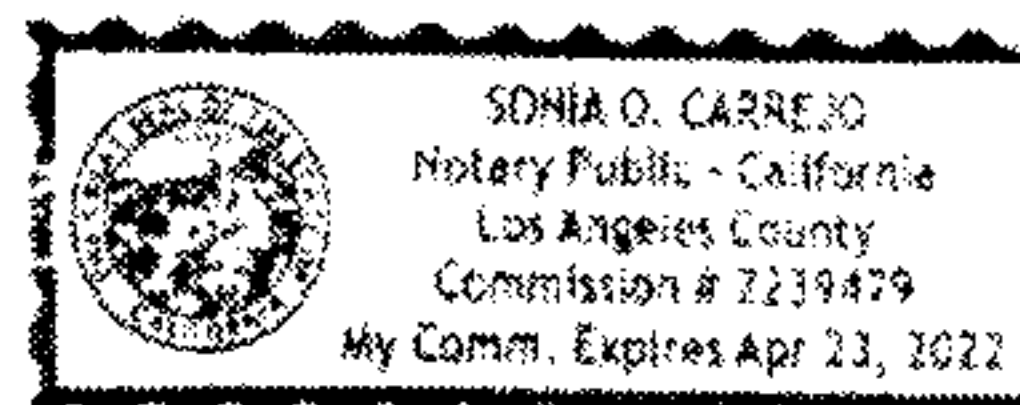
