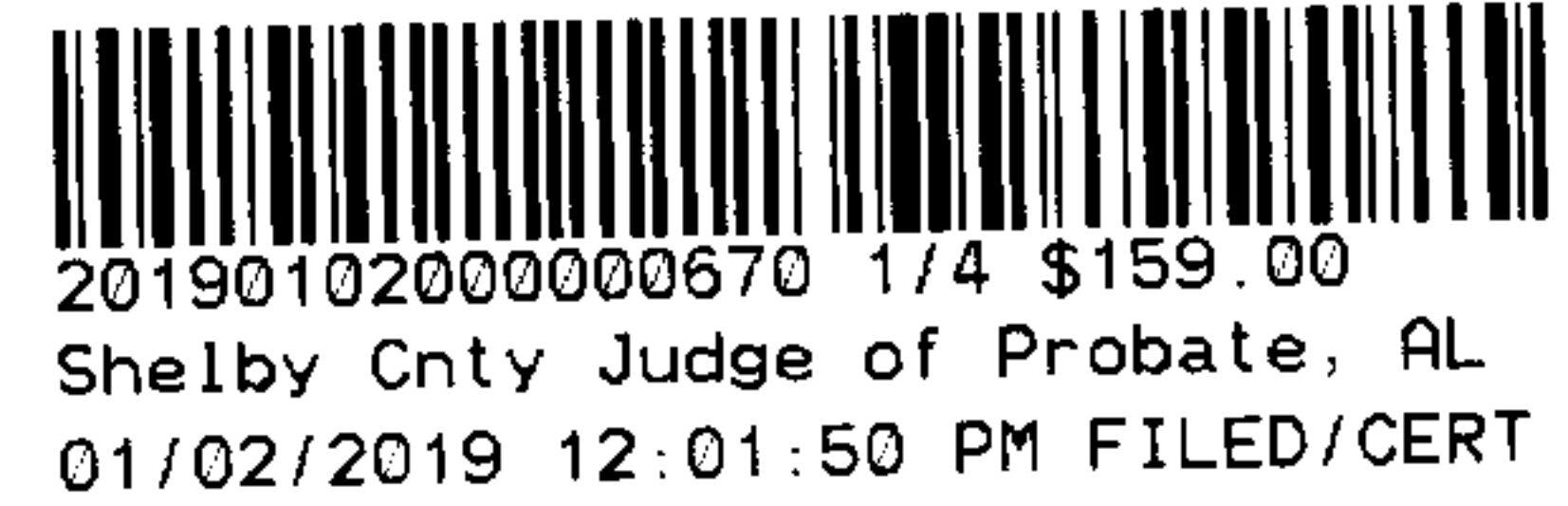

TO THE HONORABLE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

The undersigned, desiring to form a limited liability company under the laws of the State of Alabama, does hereby adopt the following Certificate of Formation (the “Certificate of Formation”):

**ARTICLE I**  
**NAME**

The name of the limited liability company shall be **Ritchey Legal, PLLC** (the “Company”).

**ARTICLE II**  
**ORGANIZATION**

The Company is hereby organized in accordance with the Alabama Limited Liability Company Law of 2014, Section 10A-5A-1.01 et seq., Code of Alabama, 2011, as amended from time to time (the “LLC Law”).

**ARTICLE III**  
**PERIOD OF DURATION**

The term for which the Company is to exist as a limited liability company shall commence on the date this Certificate of Formation is filed in the office of the Judge of Probate of Shelby County, Alabama, and shall continue in perpetual existence or until the Company shall be dissolved (a) upon the written consent of all Members of the Company, (b) as provided in the Limited Liability Company Agreement of the Company (the “PLLC Agreement”), or (c) as may be required by the LLC Law or other applicable laws.

ARTICLE IV  
LOCATION OF REGISTERED OFFICE  
AND NAME OF REGISTERED AGENT

The initial registered office of the Company shall be at 4951 Meadow Brook Rd, Birmingham, Alabama 35242, and the name of the initial registered agent at such address shall be Brian J. Ritchey.


ARTICLE V  
MEMBERS

The Company may have one or more classes of Members as provided in the PLLC Agreement. The Company has at least one Member, and the names and addresses of the initial Members of the Company are set forth in the PLLC Agreement. The Company has at least one Member who is a professionally licensed attorney under the Laws of the State of Alabama. The initial interests of the Member(s) in the Company (the "Company Interests") shall be as set forth in the PLLC Agreement.


