#### SALES AGREEMENT

WHEREAS, it is the Seller's desire to sell 50% of the property of the tire repair service and the contents thereof together with certain equipment and it is the Buyer's desire to purchase the same which is together with all inventories, license and good will [attached hereto as Exhibit "A"].

**NOW, THEREFORE**, in consideration of their mutual promises, agreements and covenants contained herein; it is mutually covenanted, promised and agreed by and between the parties hereto as follows:

- 1. **EFFECTIVE DATE**. This Agreement shall become effective upon the date of execution hereof as evidenced by the parties' signatures hereon.
- 2. AMMOUNT OF SALE. The Buyer [E&J TIRE CENTER, LLC represented by ERICK V HERNANDEZ GORDILLO] is going to pay to Sellers JOSE L. CASTELAN RODRIGUEZ] the sum of Twenty Thousand U.S. Dollars (\$20.000.00) at the same moment that this agreement will be sign.
- 3. **PAYMENT OF TAXES**. Buyer shall hereafter be responsible for paying all sales tax, income tax, or other taxes due from operation of the tire repair service *after* **January 04**<sup>th</sup>, **2019**. Seller is responsible for all sales tax, income tax, or other tax liability *prior to* **January 05**<sup>th</sup>, **2019**.
- 4. **ENTIRE AGREEMENT**. This agreement represents the entire agreement between the parties and said agreement shall not be altered or amended except by written agreement between the parties.
