KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of June, 2015, Robert Bradley Kiker, a married person and Codi Michelle Kiker, nontitled spouse joining as to marital/homestead rights only, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Freedom Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20150618000204060; rerecorded in Instrument No. 20150807000272310, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC d/b/a Mr. Cooper, by instrument recorded in Instrument No. 20180727000268930, in the aforesaid Probate Office ("Transferee"); and

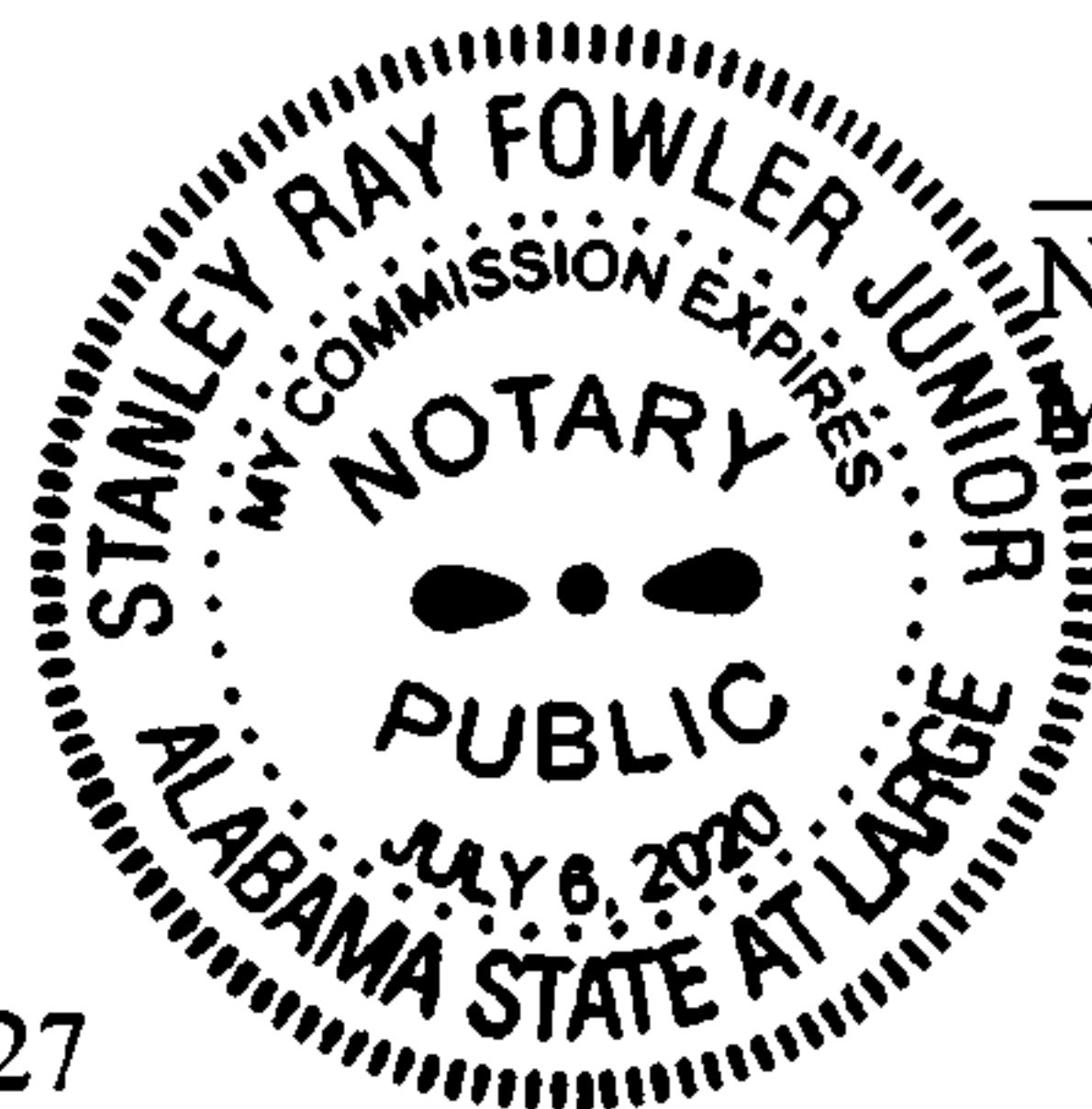

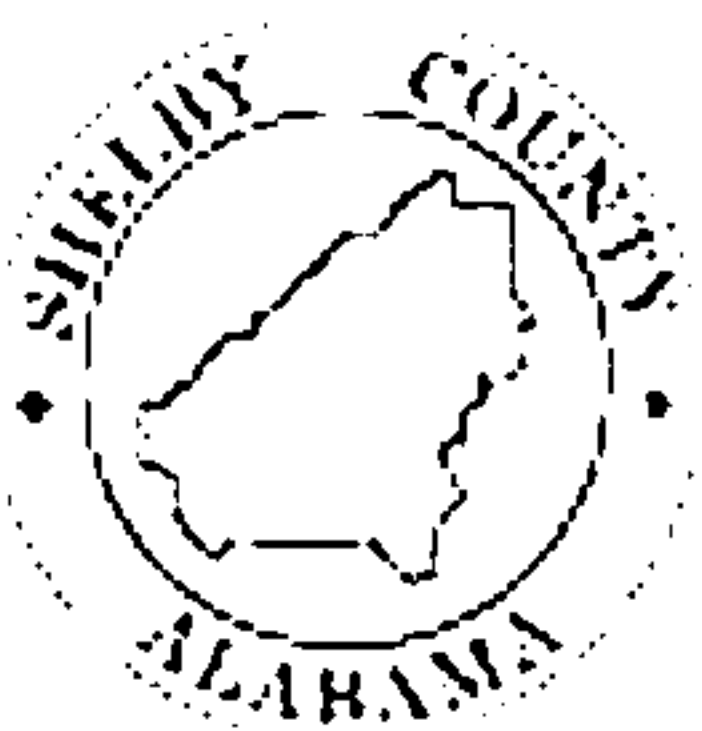
